### Subcontractor Bids

#### Bid mistakes

- N.J.S.A. 40A:11-23.3(b)
- A bidder may request withdrawal of a bid, due to a mistake on the part of the bidder, within five business days after a bid opening.
- The following requirements must be met:
  - 1. The enforcement of the contract, if actually made, would be unconscionable;
  - 2. The mistake relates to a material feature of the bid;
  - 3. The mistake occurred notwithstanding the fact that the bidder exercised reasonable care in preparation of the bid; and
  - 4. The bidder making the mistake is able to get relief by way of withdrawing the bid without serious prejudice to the contracting unit, except for the loss of the bargain to the contracting unit.

#### Failure to honor a bid

- Promissory estoppel a number of conditions must exist
  - 1. The bid must present a clear and definite offer to perform work at a specified price;
  - 2. The subcontractor must reasonably expect that the general contractor will rely on its bid;
  - 3. The general contractor must in fact rely on the subcontractor's bid and such reliance must be reasonable under the circumstances; and
  - 4. The general contractor must have suffered harm as a consequence of relying on the subcontractor's bid and its subsequent refusal to perform as promised.



## Payments to Subcontractors

"Pay If Paid" and "Pay When Paid" Clauses

- Under a pay-if-paid clause, a subcontractor is paid only if the prime contractor receives payment from the owner.
- Under a pay-when-paid clause, a contractor must pay a subcontractor on receipt of payment from the owner.

Prompt Pay Act – (NJSA 2A:30A-2)
