Total Fund ex Police and Fire Mortgages as of 11/30/13

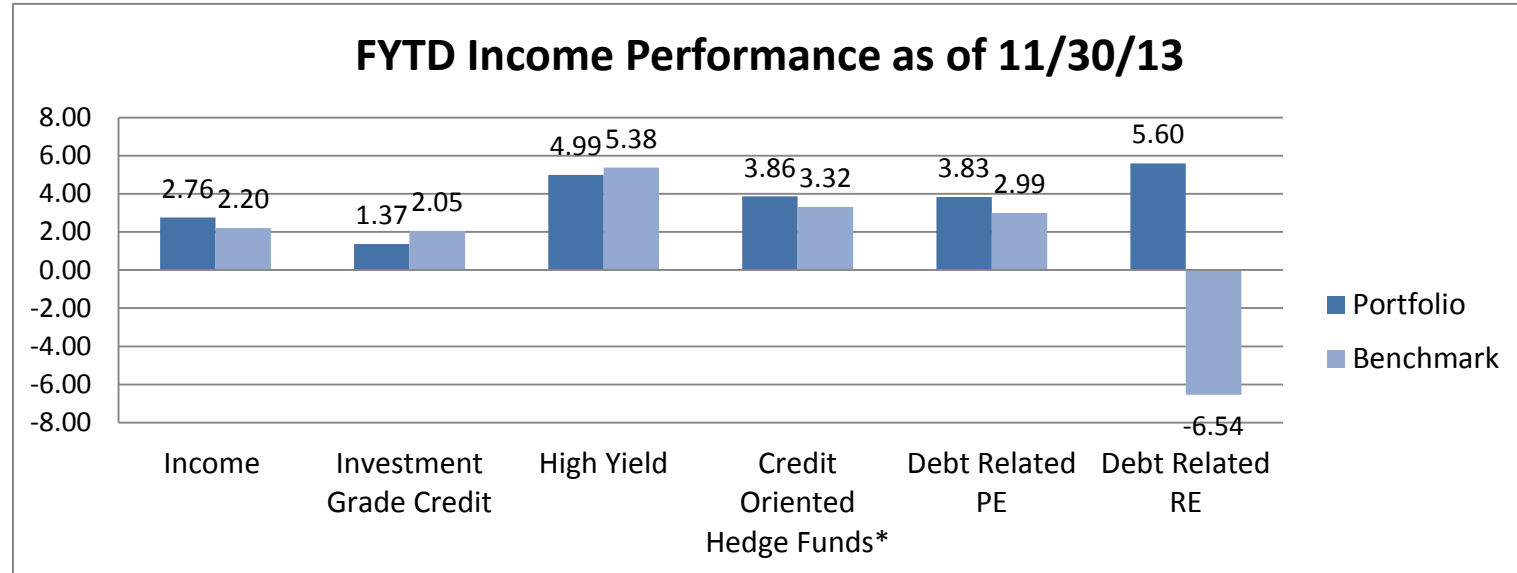
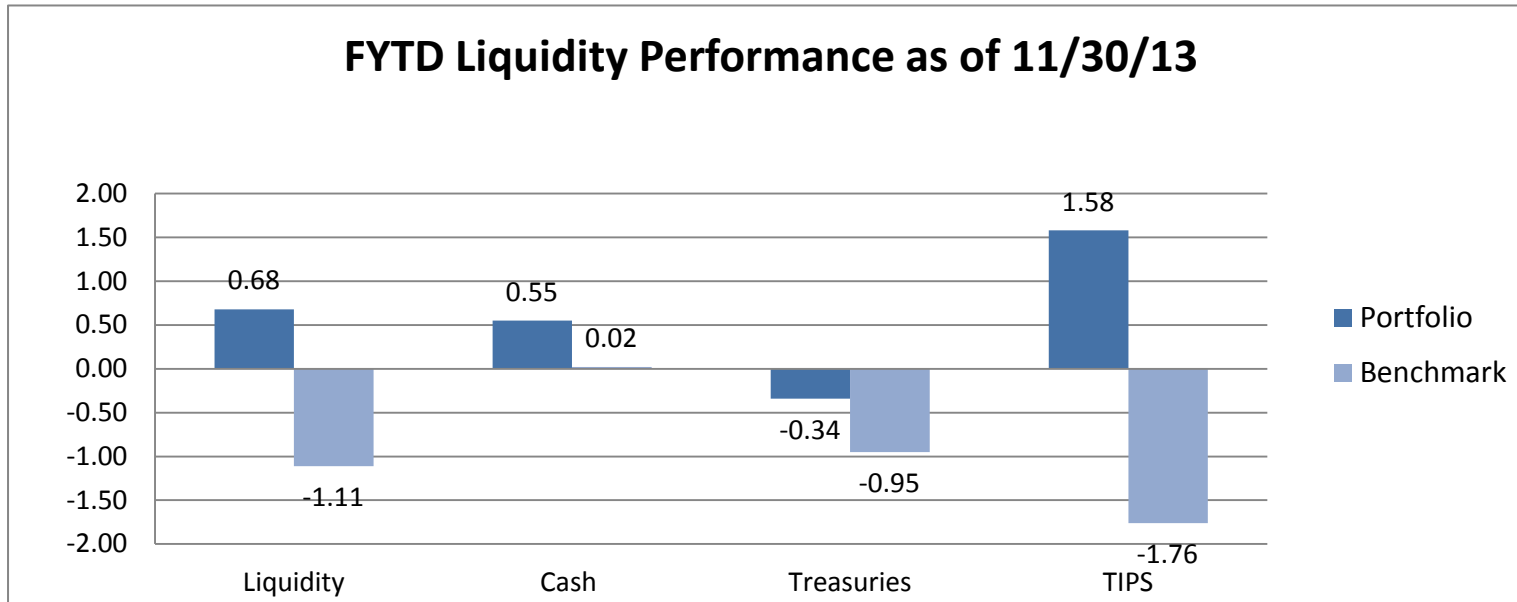
