Viewing Your Retired Account Information

*For Retired Members of PERS, TPAF, PFRS, SPRS,
and Beneficiaries Receiving a Survivor Benefit*

This step-by-step guide will assist retired members from Public Employees' Retirement System (PERS), Teachers' Pension and Annuity Fund (TPAF), Police and Firemen's Retirement System (PFRS), State Police Retirement System (SPRS), and beneficiaries who are receiving a survivor benefit with viewing their retired account information.

Retired pension members must use the Member Benefits Online System (MBOS) to view their personal data, pension allowances and deductions, and other benefit information. Authorized users can register for an MBOS account here:

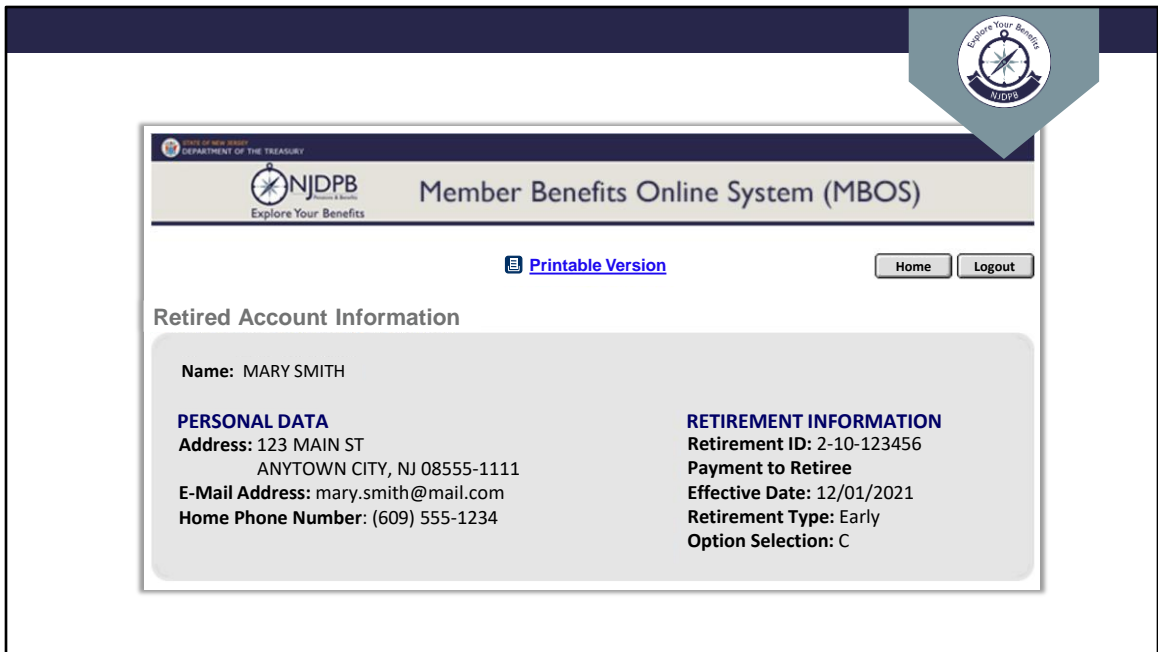
