16:60-3.2 Aircraft incident and forced landing reporting requirements

(a) The pilot or aircraft operator involved in an incident shall immediately notify the FAA Communications Center at [718-553-3100] **404-305-5150** or the New Jersey State Police at 609-882-2000.

(b) The pilot or aircraft operator involved in a forced landing shall immediately notify the FAA Communications Center at [718-553-3100] **404-305-5150** or the New Jersey State Police at 609-882-2000.

(c) (No change.)

(d) When deemed necessary by a designated law enforcement officer, the pilot or aircraft operator shall complete the New Jersey Department of Transportation Form DA-25-1, "Aircraft Accident/Incident Statement of Pilot," for any incident or forced landing involving the operation of an aircraft, which occurs in the State of New Jersey. 16:60-3.5 Statements of witnesses

When deemed necessary by a designated law enforcement official, New Jersey Department of Transportation Form DA-25, "Aircraft Accident/Incident Statement of Witness," shall be completed by any person or persons who observed the actual aircraft accident or incident, or any events prior to or immediately following said accident or incident and shall include the place, date, and time of the accident/incident; make, mode, and tail number of the aircraft; the witness's identification information; and a description of the accident/incident. Take notice that, pursuant to N.J.S.A. 52:14B-5.1.c, the rules at N.J.A.C. 18:24A were scheduled to expire on January 20, 2022. N.J.A.C. 18:24A outlines the organization and operational procedures of the Sales and Use Tax Review Commission (Commission). P.L. 1999, c. 416, § 2 (N.J.S.A. 54:32B-37) created the Commission to review any bill, joint resolution, or concurrent resolution introduced in either house of the New Jersey Legislature that expands or reduces the New Jersey sales and use tax base. This review includes, but is not limited to, an analysis of a bill's or resolution's fiscal impact, any comments or recommendations concerning the legislation, and any alternatives to the legislation the Commission may suggest. The Division of Taxation has reviewed these rules and has determined that the rules should be readopted because they are necessary, reasonable, and proper for the purpose for which they were originally promulgated. Therefore, pursuant to N.J.S.A. 52:14B-5.1.c(1), N.J.A.C. 18:24A is readopted and shall continue in effect for a seven-year period.
