

## DCA's Eviction Diversion Initiative (EDI)

DCA is implementing a **NEW** Housing Resource Navigator pilot program through its Eviction Diversion Initiative (EDI) with the goal of diverting low-income households from eviction. This initiative compliments DCA's earlier diversion efforts such as the Access to Counsel pilot.

Who is it for? - Low-income households facing eviction or other housing related challenges.

What can Housing Resource Navigators help with? – They are case workers experienced in eviction and homelessness prevention who have been integrated within landlord-tenant courts in every vicinage across the state. These navigators can provide the following assistance:

- Landlord-tenant court counseling and access to legal services. They can also attend court events (case management conferences and trials) to assist tenants facing eviction.
- Housing counseling or mediation
- Rental assistance, homelessness prevention/rapid rehousing
- Emergency support through flexible funding
- Case management
- Linkage to other services (such as Board of Social Services, Continuum of Care; childcare resources or support; utility, employment, etc.)

There are currently, twenty-eight (28) resource navigators Statewide.
