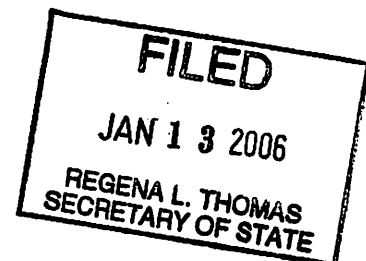

ORDINANCE 2005

05-OR-041

AN ORDINANCE ADOPTING "NEW JERSEY LOCAL UNIT PAY-TO-PLAY",
P.L. 2004, CHAPTER 19 (as amended by P. L. 2005, c 51)
N.J.S.A. 19:44A-20.4, et seq.

BE IT ORDAINED by the Council of the Township of Burlington, in the County of Burlington, as follows:

Section 1. Findings: The Council of the Township of Burlington has determined to adopt as an ordinance for the Township of Burlington the "New Jersey Local Unit Pay-to-Play" Law P. L. 2004, CHAPTER 19 (as amended by P. L. 2005, c.51) N.J.S.A. 19:44A-20.4 et seq. The New Jersey Local Unit Pay-to-Play Ordinance for the Township of Burlington shall include any and all amendments to said statute and regulations, including interpretation of said regulations.

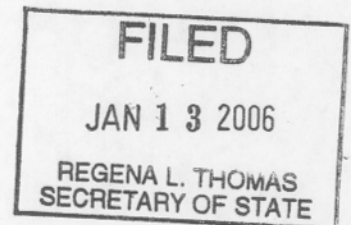
Section 2. Effective Date: This Ordinance shall take effect with the Ordinance being passed on final adoption and published in the manner provided by law.


Section 3. Repealer: All provisions of current Township Ordinances which are inconsistent with the provisions of this Ordinance are hereby repealed.

Section 4. Invalid Portions; Savings: Should any portion of this Ordinance be declared invalid by any Court having jurisdiction, the remaining portions of this Ordinance shall remain valid to the fullest extent possible.
