## N.J.S.A. 19:61-9: AUDITS OF ELECTION RESULTS

November 7, 2023 General Election and Audit Date: November 20, 2023

The Burlington County Board of Elections performed a post-election audit consistent with the provisions of N.J.S.A. 19:61-9 and the guidelines promulgated by the New Jersey Secretary of State's Office on Tuesday, November 20, 2023. The audit was open to the public and our Board was present.

The Burlington County Board of Elections conducted a hand-to-eye count for the November 7, 2023 General Election for the offices of the County Clerk, State Senator, General Assembly, Municipal Mayor or Council/Committee in all batches selected. In accordance with the law, Public Questions, School Elections, and Fire District Elections were not audited.

Pursuant to the statute, "the audit shall be conducted in at least 2% of the election districts in which each audited election appears on the ballot." The guidelines provided for this audit require 2% of the audit units in each of the congressional districts to be randomly selected. Audit units included: early voting ballots, vote-by-mail ballots, and provisional ballots. In total, 484 audit units were created.

There are four Legislative Districts in Burlington County: Sixth, Seventh, Eighth, and Twelfth. There were 12 audit units for the 6<sup>th</sup> Legislative Congressional District and 2 batches were audited. There were 247 audit units for the 7<sup>th</sup> Legislative District and 5 batches were audited. There were 219 audit units for the 8<sup>th</sup> Legislative Congressional District and 5 batches were audited. There were 6 audit units for the 12<sup>th</sup> Legislative District and 2 batches were audited.
