There are different Electronic Signatures available, such as digitized signatures, biometrics, passwords, personal URL addresses, personal identification numbers (PINs), smart cards, and "I Agree" buttons. Since the parents' personal URL address were used as the digital signature, the applications did have an adult signature under the definition of Digital Signature. The Electronic application system was correct and the students name is no longer written next to the parents' email. The electronic system was corrected by updating the parents' account connecting to the child and updating the head of household to the parents' name.
