Based on how the daily main entree & hot vegetable are recorded on the PR, it appears that the veg is part of the main entrée, automatically plated, & only offered to students that take the main entree. Both food items are recorded together and have the same number of portions planned/left over/reimbursable portions used. In this review, this was not an error because the menu also offered two daily cold vegetable options in the "Maschio's vegetable patch" that meet the weekly vegetable subgroup requirement and SFA confirmed hot veg offered to all. However, wanted to note that if there was a substitution to the planned MVP with a diff veg subgroup it could risk not meeting the weekly req's if it is determined on-site review that the hot veg is not available to all.
