## NJ Board of Public Utilities Holds Annual Supplier Diversity Conference

**Piscataway, N.J.** - The New Jersey Board of Public Utilities Supplier Diversity Development Council (SDDC) today held its annual conference at Rutgers University. The event is designed to help diverse business owners, particularly those who are minority, women, and service disabled veteran-owned businesses (M/W/SDVBEs), understand how they can obtain potential contracting opportunities from the state's utilities.

This year, the SDDC, honored veterans with a color guard salute and other acknowledgements.

"The SDDC provides opportunities for regulated utilities and diverse suppliers to work together to fill the utilities' business needs," said NJBPU President Richard S. Mroz. "Encouraging diversity is not only the right thing to do, but it also is an investment in New Jersey's economy, and helps to create jobs."

Today's event showcased the diversity efforts encouraged by the SDDC and the state's regulated utilities. The conference's presenters advised the representatives of minority-owned firms what they have to do to qualify for a contract, made it clear to them what they need to think of when bidding on a contract, and provided information on requirements they may need to implement internally to be in a position to win and successfully complete a contract.

"In particular, one of the areas where minority, women, and service disabled veteran-owned businesses must make sure they have all their bases covered is cybersecurity. A supplier's ability to show that they maintain appropriate cybersecurity safeguards will enhance their opportunities for potential agreements," said President Mroz."

The SDDC also offers prospective suppliers an avenue to improve their financial strength so they are capable of pursuing and fulfilling contracts with the regulated utilities.
