BY PRESIDENT ROBERT M. HANNA:

By Order dated November 30, 2011, in Docket No. EO11090528, the Board of Public Utilities ("Board") determined to retain jurisdiction to hear the request from the Division of Rate Counsel ("Rate Counsel") that the Board require Jersey Central Power and Light Company ("JCP&L") to file a base rate case, predicated upon Rate Counsel's assertion that JCP&L is earning a rate of return that is in excess of "just and reasonable" rate. The Board determined that while it has the authority to direct the filing of a base rate case under N.J.S.A. 48:2-21, all appropriate persons should have an opportunity to provide the Board with written submissions before a final decision is made.

The Board further appointed the President of the Board to serve as the presiding officer to rule on all motions and set and modify any schedules as necessary to secure a just and expeditious determination of the issues.

Under that authority, I **HEREBY SET** the following procedural schedule.
