RESOLUTION 2024-<u>211</u> APPROVAL OF APPLICATIONS TO CHANGE THE BUSINESS NAMES OF ADULT-USE LICENSE AWARDEES

WHEREAS, the Commission is charged with implementing the provisions of P.L.2021, c.16, known and cited as the "New Jersey Cannabis Regulatory, Enforcement Assistance, and Marketplace Modernization Act"; and

WHEREAS, the regulations for personal-use cannabis provide a process at N.J.A.C. 17:30-9.2 for changes to an issued adult-use cannabis license or award, including changes of the business's name; and

WHEREAS, the four (4) adult-use cannabis annual license awardees listed below have requested a change to each of their respective business names; and

WHEREAS, the four (4) adult-use cannabis annual license awardees have each followed the requirements set forth at N.J.A.C. 17:30-9.2; and

WHEREAS, each of these license awardees has submitted documentation of a valid Business Registration Certificate on file with the New Jersey Department of the Treasury, Division of Revenue and Enterprise Services with its amended business name;
