

DESIGNATION OF AGENT FOR SERVICE OF PROCESS

The purpose of this form is to assure that all legal matters and actions that may arise out of activities related to junkets governed by the Casino Control Act (N.J.S.A. 5:12-92c and 102j) may be heard and decided by the courts of New Jersey if an aggrieved party so desires.

INSTRUCTIONS:

Read these instructions carefully prior to completing this form. All entries on this form, except initials and signatures, must be typed or printed in block letters. Use black ink. If an application is not legible, it will not be accepted. Initial each page of this form in the space provided. Retain a completed copy of this form for your own records.

PART I:

Every applicant/licensee must complete Part I of this form. If your residence or principal place of business is located in New Jersey, you may provide your own name and address in this space. Otherwise, the name and address of the person or company designated as your agent for service of process must be someone legally authorized to accept service of process in New Jersey on your behalf. The basis of this authority should be indicated by checking the appropriate box.

The obligation to designate an agent for service of process may be satisfied by granting a limited power of attorney to a person to accept service of process in New Jersey on your behalf in all matters or actions that may arise out of activities related to junkets governed by the Casino Control Act (N.J.S.A. 5:12-92c and 102). If an agent is designated pursuant to such a power of attorney, you should confirm this agreement in writing. This confirmation should be retained in your own files. Regardless of the basis of authority indicated on the attached form, the Commission or Division of Gaming Enforcement may require you at any time to present evidence that the agency claimed on this form has actually been established.

PART II:

The designation required by Part II of this form may not be substituted for the obligation created in Part I.

AFFIRMATION:

An authorized representative (officer, partner or sole proprietor) of the junket enterprise applicant/licensee, as appropriate, must sign this form in the presence of a notary public.

I understand that by signing this document, I am agreeing on behalf of the enterprise submitting this form to permit legal matters and actions that may arise out of the activities of such enterprise related to junkets governed by section 92c and 102 of the Casino Control Act to be filed and litigated in the State of New Jersey.
