MINUTES - PUBLIC MEETING NO. 15-02-11 February 11, 2015 - 10:30 a.m.

Subsequent to the reading of a statement of compliance with the notice requirements of the Open Public Meetings Act and identification of items discussed during closed session, the Commission considered and took formal action on the following matters:

- 1. By votes of 3-0, ratified the minutes of January 14, 2015 public meeting; and the special meeting of January 29, 2015 (transcript pages 7-9).
- 2. By a vote of 3-0, granted the applications of Dominique A. Burrows, Joseph E. Vanderslice, IV and Troy J. Vanke for initial casino key employee licenses (Exhibit EL-1*; transcript pages 9-10); and

By a vote of 3-0, remanded the initial application of Margarita Rivera for a casino key employee license to a hearing (Exhibit EL-2*;transcript pages 10-11).

3. By a vote of 3-0, granted the resubmitted application of Michael D. Young for a casino key employee license (Exhibit EL-2* transcript page 11-12);

By a vote of 3-0, remanded the resubmitted application of Lisa M. Shepeski for a casino key employee license to a hearing (Exhibit EL-2*;transcript pages 12-13); and

By a vote of 3-0, remanded the resubmitted application of Rakeem D. Stewart for a casino key employee license to a hearing (Exhibit EL-2*;transcript pages 13-14).

- 4. Temporary casino key employee licenses were issued between January 12, 2015 and February 9, 2015, pursuant to Delegation of Authority Resolution Number 13-01-10-16-C to the following applicants: Christina F. Best, Joseph J. Devine, Sr. and Steven M. Roff (Exhibit EL-4*; transcript pages 14-15).
- 5. By a vote of 3-0, granted the requested relief and inactivated the casino key employee licenses held by Holly A. Cantell, Stacy A. DiFelice, Carol A. lannaco, James J. Kennedy, Robert M. McNellis, Sharon R. O'Grady, Lina Perry and David Syroczynski (Ruling numbers 15-02-11-05-A; 15-02-11-05-B; 15-02-11-05-C; 15-02-11-05-F; 15-02-11-05-G; 15-02-11-05-H; transcript pages 15-16).
- 6. By a vote of 3-0, approved the termination of the casino key employee license held by Maureen F. Scheffler (Ruling number 15-02-11-06; transcript pages 16-17).
- 7. By a vote of 3-0, approved the stipulation of settlement between the Division of Gaming Enforcement and Marc R. Taylor; and granted the resubmitted application of Mr. Taylor, for a casino key employee license, subject to compliance with certain financial and reporting conditions as provided for in the stipulation (DKT 14-0038-CR) (Ruling number 15-02-11-07; transcript pages 17-19).
- 8. Considered the amended petition of Caesars Entertainment Corporation, Caesars Entertainment Operating Company, Inc., Harrah's Atlantic City Operating Company, LLC, Bally's Park Place, Inc. and Boardwalk Regency Corporation and issued the following ruling:

By a vote of 3-0, adopted the draft resolution and authorized Mark P. Frissora, on a temporary basis and prior to his plenary qualification, to assume the duties and exercise the powers of Chief Executive Officer for Caesars Entertainment Corporation, pending plenary qualification, subject to the conditions contained in *N.J.S.A.* 5:12-85.1c and *N.J.A.C.* 13:69C-2.7 (c) of the Act (PRN 0341501) (Ruling number 15-02-11-08; transcript pages 19-24).

9. Considered the petition of Revel Entertainment Group, LLC and issued the following rulings:

By a vote of 3-0, found good cause, and granted the requested relief, pursuant to *N.J.S.A.* 5:12-75, until June 5, 2015; and

- a) Extended Shaun M. Martin temporary casino key employee license and permitted him to continue the duties of Chief Restructuring Officer for Revel Entertainment Group, LLC, pursuant to *N.J.S.A* 5:12-89 (e); and
- b) Extended the waiver of residency requirement, as provided in N.J.S.A. 5:12-89-b4 (PRN 0361502) (15-02-11-09; transcript pages 24-28).

In accordance with Resolution No. 14-12-10-03, the next closed session of the Commission shall be held on Wednesday, March 11, 2015 at 10:30 a.m. in the Commission Offices (transcript page 28).

There being no members of the public to address the Commission, the meeting adjourned at 10:48 a.m.
