
WHEREAS, Caesars Entertainment Corporation, a qualified holding company of casino licensees Harrah's Atlantic City Operating Company, LLC, Bally's Park Place, Inc., Boardwalk Regency Corporation, and Caesars Interactive Entertainment New Jersey, LLC, (Petitioners) having filed a petition seeking approval of the New Jersey Casino Control Commission (Commission) to have Leslie Marcel Ottolenghi, prior to his plenary qualification, assume the duties and exercise the powers of the Chief Information Officer of Caesars Entertainment Corporation for a nine-month period in accordance with the conditions contained in *N.J.S.A. 5:12-85.1c* and *N.J.A.C. 13:69C-2.7(c)* and (d); and

WHEREAS, the Commission considered the entire record of the proceedings at its public meeting of February 10, 2016;


