

## SETTLEMENT AGREEMENT AND MUTUAL RELEASE

THIS SETTLEMENT AGREEMENT AND MUTUAL RELEASE (“Settlement Agreement”) is entered into this 22<sup>nd</sup> day of December, 2017 (“Effective Date”) by and between SPECIAL CARE OB/GYN (“Special Care OB/GYN”), its owners, directors, officers, successors and assigns, represented by Riza I. Dagi, Esq., of Brach Eichler LLC; and STATE OF NEW JERSEY, OFFICE OF THE STATE COMPTROLLER, MEDICAID FRAUD DIVISION (“MFD”). Special Care OB/GYN and MFD are hereinafter collectively referred to as the "Parties" and each individually as a “Party.”

WHEREAS, MFD investigated Special Care OB/GYN and determined that between July 1, 2009 and August 31, 2014, Special Care OB/GYN submitted for reimbursement claims that were not supported by required clinical documentation, in violation of N.J.S.A. 30:4D-12, N.J.A.C. 10:49-9.8, N.J.A.C. 10:54-9.1 (“the Covered Conduct”), resulting in Special Care OB/GYN receiving overpayments from the Medicaid Program; and

WHEREAS, Special Care OB/GYN has asserted that all services for which Special Care OB/GYN submitted claims to be paid by Medicaid program funds were performed and properly supported by documentation; and

WHEREAS, the parties desire to amicably resolve all disputes between them giving rise to the Covered Conduct and have reached a mutually acceptable resolution of the controversies that exist between them;

NOW THEREFORE, in consideration of the mutual promises contained herein, as well as for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree to settle their dispute on the following terms:

(1) Special Care OB/GYN agrees to pay restitution to the Medicaid program in the sum of One Hundred Fifty Thousand Dollars (\$150,000.00), in the following manner:

(a) A payment of Twenty Five Thousand Dollars (\$25,000.00) shall be remitted no later than the close of business on the last day of January, 2018;

(b) Each following month, for a period of five months, a payment of Twenty Five Thousand Dollars (\$25,000.00) is to be remitted no later than the close of business on the last day of the month.

(2) Payment shall be by certified check, bank check, or attorney trust check made payable to “Treasurer, State of New Jersey,” and shall be mailed or delivered as follows:

Special Care OB/GYN will include “Special Care OB/GYN – OSC-MFD” in the memo line so that it is properly credited.

(3) If the payment arrangement as provided for in this Settlement Agreement is more than ten (10) days late, Special Care OB/GYN will be in default of this Settlement Agreement and the outstanding and unpaid balance plus interest will immediately become due and collected through any means available to MFD as provided by law.

(4) The parties agree that this Settlement Agreement is intended to be a final resolution of all issues arising out of the Covered Conduct, referenced above, and is intended by each party to release the other party and its representatives from liability arising out of the Covered Conduct, unless MFD is mandated to act by federal or State law; or mandated by order or judgment of a court or administrative agency (other than MFD).

(5) Nothing in this Settlement Agreement waives the rights of any other State or federal agency, including, among others, the New Jersey Division of Criminal Justice, from continuing with a pending or beginning a future civil or criminal investigation or other action for alleged conduct concerning Special Care OB/GYN or from taking any action for such conduct. Nothing in this Settlement Agreement waives the rights of MFD to conduct an audit or investigation of prior or future years for the improper submission of any claims or conduct not specifically covered by this agreement, and to take any action civilly or criminally for such conduct. Nothing in this Settlement Agreement waives any defenses that Special Care OB/GYN, its officers, directors, successors or assigns may raise with respect to claims of any nature that may be raised by MFD or any other state or federal agency.

(6) Subject to the express terms of this Settlement Agreement as provided for in paragraphs 1-5 above, by the signatures set forth below, the authorization of which is hereby affirmed, Special Care OB/GYN and MFD agree to the following release: in consideration of the provision hereof including this release, each party agrees to release the other party and its representatives from liability, obligations and damages arising out of the Covered Conduct, referenced above.

(7) Nothing herein shall constitute an admission, concession or finding of wrongdoing or liability by any party.

(8) This Settlement Agreement shall be construed, enforced and governed by the laws of the State of New Jersey.

(9) This Settlement Agreement may be executed in Counterparts.


(10) This Settlement Agreement is effective upon the last date it is executed by the parties hereto.


