- 1.8 COMPLIANCE: CODES The contractor musty comply with NJUCC and the latest NEC70, B.O.C.A. Basic Building Code, OSHA and all applicable codes for this requirement. The successful vendor will be responsible for securing and paying for all necessary permits, where applicable.

- 2.1 LIABILITIES COPYRIGHT The contractor shall hold and save the State of New Jersey, its officers, egents, servents and employees, harmless from liability of any nature or kind of or on account of the use of any copyrighted or uncopyrighted composition, secret process, patented or unpatented invention, article or appliance lumished or used in the performance of this contract.
- 2.2 INDEMNIFICATION The contractor shall assume all risk of and responsibility for, and agrees to indemnify, defend and save harmless the State of New Jersey and its employees from and against any and all claims, demands, sultos, actions, recoverles, judgment and costs and expenses in connection therewith on account of the loss of life, property or injury or damage to the person, body or property of any person or persons whatsoever, which shall arise from or result directly or Indirectly from the work and/or materials supplied under this contract. This indemnification obligation is not limited by, but is in addition to, the insurance obligations contained in this agreement.
- 2.3 INSURANCE The contractor shall secure and maintain in force for the term of the contract liability insurance as provided herein. The contractor shall provide the State of New Jersey with current certificates of insurance for all coverage's and renewals thereof which must contain the provision that the insurance provided in the certificate shall not be canceled for any reason except after thirty days written notice.

The insurance to be provided by the contractor shall be as follows:

- a. General liability policy as broad as the standard coverage forms currently in use in the State of New Jersey shall not be circumscribed by any endorsements limiting the breadth of coverage. The policy shall be endorsed to include:

Nothing contained in the specifications shall be construed as creating a contractual relationship between any subcontractor and the State.

- 3.2 PERFORMANCE GUARANTEE OF BIDDER The bidder hereby certifies that:
- a. The equipment offered is standard new equipment, and is the manufacturer's latest model in production with parts regularly used for the type of equipment offered; that such parts are all in production and not likely to be discontinued; and that no attachment or part has been aubstituted or applied contrary to manufacturer's recommendations and standard practice. b. All aquipment supplied to the State and operated by electrical current to UL listed where applicable.
- c. All new machines are to be gueranteed as fully operational for the period stated from time of written acceptance by the State. The bidder will render prompt service without charge, regardless of geographic location.
- d. Sufficient quantities of parts necessary for proper service to equipment will be maintained at distribution points and service headquarters,
- e. Trained mechanics are regularly employed to make repairs to equipment in the territory from which the service request might emanate within a 48 hour period or within the time accepted as industry practice.
- f. During the warranty period, the contractor shall replace immediately any material which is rejected for falture to meet the requirements of
- g. All services rendered to the State shall be performed in strict and full accordance with the specifications stated in the contract. The contract shall not be considered complete until final approval by the State's Using Agency is rendered.

In the event delivery of goods or services is not made within the number of days stipulated or under the schedule defined in the specificallons, the Using Agency may be authorized to obtain the material or service from any available source, the difference in price, if any, to be paid by the contractor failing to meet his commitments.

- 3,4 STATE'S RIGHT TO INSPECT CONTRACTOR'S FACILITIES The State reserves the right to inspect the contractor's establishment.
- 3.5 MAINTENANCE OF RECORDS The contractor shall maintain records for products and/or service delivered against the contract for a period of three (3) years from the date of final payment. Such records shall be made available to the State upon request.
- 4. TERMS RELATING TO PRICE QUOTATIONS
- 4.1 PRICE FLUCTUATIONS DURING CONTRACT All prices shall be firm through Issuance of contract purchase order and shall not be subject to increase during the period of the contract.
- 4.2 DELIVERY COSTS Unless otherwise noted in this purchase order, all prices for items are to be F.O.B. Destination. Regardless of the methods of quoting shipment, the contractor shall assume all liability and responsibility for the delivery of merchandise in good condition to the State' Using Agency or designated purchaser.

No additional charges will be allowed for any transportation coats resulting from partiel shipments made at the contractor's convenience when a single shipment is ordered. The weights and measures of the State's Using Agency receiving the shipment shall govern.

4.3 C.O.D TERMS - C.O.D. terms are not acceptable.

- 4.4 TAX CHARGES The State of New Jersey is exampl from State sales or use taxes and Federal excise texes. Therefore, they must not be included in the invoice. The State's Federal Excise Tex Examplion Number is 22-75-0050k.
- 4.5 PAYMENT TO VENDORS Payment for goods and/or services purchased by the State will only be made against State Payment Vouchers. The State Payment Vouchers in duplicate together with original Bill of Lading, express receipt and other related papers must be sent to the consignor on the date of each delivery.
- 4.6 NEW JERSEY PROMPT PAYMENT ACT The New Jersey Prompt Payment Act (P.L.1987, c. 184) requires state agencies to pay for goods and services within sixty (60) days of the agency's receipt of a property executed State Payment Voucher or within sixty (60) days of receipt and acceptance of goods and services, whichever is later.

#### 5. CASH DEPOSITS

- a. A discount period shall commence on the day the State Using Agency received a properly signed and executed State Payment Voucher for products and services that have been duly accepted by the State Using Agency in accordance with the terms, conditions end specifications of the Contract/Purchase Order. The solicitation of any fee, commission, compensation, glft, gratuity or other thing of value by any State officer or employee or special State officer or employee from any State vendor shall be reported in writing forthwith by the vendor to the Attorney General and the Executive Commission on Ethical Standards.
- c. No vendor may, directly or indirectly, undertake any private business, commercial or entrepreneurial relationships with, whether or not pursuant to employment, contract or other agreement; express or implied, or sell any interest in such vendor to, any State officer or employee or special state office or employee having any dutter or responsibilities in connection with the purchase, acquisition or sale of any property or services by or to any State agency or any instrumentality thereof, or with any person, firm or entity with which he is employed or associated or in which he has an interest within the meaning of N.J.S.A. 52:13D-13g. Any relationships subject to this provision shall be reported in writing forthwith to the Executive Commission on Ethical Standards, which may grant a waiver of this restriction upon application of the State officer or employee or special state officer or employee upon a finding that the present or proposed relationship does not present the potential, actually or appearance of a conflict of interest.
- d. No vendor shall influence, or altempt to cause or influence, any State officer or employee or special State officer or employee in his official capacity in any manner which might lend to impair the objectivity or independence of judgment or said officer or employee.
- e. No vendor shall cause or influence, or attempt to cause or influence, any State officer or employee or special State officer or employee to use, or attempt to use, his official position to secure unwarranted privileges or advantages for the vendor or any other nerson.
- f. The provisions clied above in paragraph 6a, shall not be construed to prohibit a State officer or employee or special State officer or employee from receiving gifts from or contracting with vendors under the same terms and conditions as are offered or made available to members of the general public subject to any guidelines the Executive Commission on Ethical Standards may promutgate under
