- Deliver approximately 347 CY of riprap armoring consisting of 12-24 inch diameter median rock.
- The riprap shall be composed of angular field or quarry stone to maintain visual uniformity.
- The bid shall include freight.
- Selected vendor will be required to complete State of NJ vendor paperwork and W9.

Figure 1: Measurement and type of existing riprap stone.





Figure 2: Measurement and type of existing riprap stone.
