# Mercer County Photography 2009

## Juror

Award-winning photographer/printmaker, Edward Fausty (BFA, Cooper Union; MFA, Yale University), a recent visiting artist at Princeton University, is known both for his photograph series (Camera Vision; A Fragile Utopia) and his experimental ink on paper works and collotypes. The recipient of a NEA Survey Grant in Photography, he exhibits widely and has works in many collections including The George Eastman House, The U.S. Library of Congress and Yale University.

## Awards

More than \$1,000 in prizes, including Best in Show, Juror's Merit, Honorable Mention, and Mercer County Purchase Awards, will be awarded.

## Eligibility

Open to all artists, 18 years or older, currently living, attending school, or employed in Mercer County. All images created utilizing photographic processes, including black and white and color photography, non-silver processes, book art, and computer derived photography are eligible. Work must have been created within the past two years. All two- and three-dimensional work must be appropriately presented for gallery installation. Two-dimensional work must be framed and wired for hanging.

## Entry Fee

Entry fee is \$20 for up to three entries per individual artist. All entries must have the completed entry label (including sales price and insurance value) securely attached to the back. Make checks payable to Mercer County Community College.

## Entry Procedures

All work must be delivered by hand to The Gallery, CM Building, Mercer County Community College West Windsor campus on August 29 from 9:30 a.m. to noon. Work NOT selected for the exhibit must be picked up by 5 pm on August 29, no exceptions. All photographs selected for the exhibition will be insured against damage and theft while on exhibit at The Gallery. Work that has not been claimed by October 12 at 8 pm will become the property of Mercer County Photography 2009.

## Reproduction Rights

Submission of entries acknowledges the right of Mercer County Photography 2009 to reproduce all or part of an entry for publication for the benefit of the exhibition.
