PROFESSIONAL SERVICES CONTRACT

This Agreement is made and entered into this _____ day of _____ 2012, by and between the New Jersey Historic Trust, an instrumentality of the State of New Jersey, in but not of the Department of Community Affairs, with offices at 101 South Broad Street, Room 134, Trenton, New Jersey 08625-0457 (hereinafter "Trust") and _____. (hereinafter "Consultant").

The Trust hereby engages the Consultant and the Consultant hereby agrees to perform in a good and skillful manner, in accordance with the directions and subject to the approval of the Executive Director, all such services in connection with the work proposal for the research, documentation and authoring of a manuscript (hereinafter "Project") as more fully set forth herein below.

I. Purpose

With the Historic Trust approaching the 25th anniversary of its Preservation Grants Program and New Jersey poised to commemorate its 350th anniversary in 2014, this project is intended to document and celebrate the leading tradition of historic preservation in New Jersey. The narrative is to be a well-researched, documented and scholarly history, with footnotes, suitable for publication and ultimately for use by scholars, students, and the general interested public. Consultant shall review the following articles published by the New Jersey Historic Preservation Office in the *Historic Preservation Bulletin* series:

This project will provide the following:

- 1. Summary documentation of New Jersey's leadership in preserving historic sites and cultural landscapes in this state in context of national movement
- 2. Summary documentation of the key stories of the people involved in preserving New Jersey's significant landscapes and historic sites;
- 3. Highlight public and private stewardship of historic sites and cultural landscapes in New Jersey and the impact of public policy initiatives and implementation;
- 4. Produce a research file/index/database documenting the preservation history for a minimum of 125 sites to be used for development of the manuscript and for future researchers; and
- 5. Synthetize research and documentation into a manuscript suitable for publication; Manuscript should be approximately 300-400 pages in length.

6. Collect/identify images that may be suitable for publication; in cases where permission is needed for reproduction, provide client with information

<u>II. Term</u>

The Term of this agreement shall be the "Commence Date", i.e., the date this agreement is fully executed between the Trust and Consultant and shall continue until the earlier of: (i) the delivery by the Consultant of the final acceptable work product and deliverables (as defined herein); (ii) termination pursuant to Section V herein; or (iii) twelve months from the Commencement Date (the "Termination Date").

III. Scope

This contract will be for Phase I and Phase II of the project as follows:

Phase I	Research and documentation – compilation of stories, documents, illustrations, and interviews into a New Jersey Preservation Research file/index/database for current and future use;
Phase II	Manuscript preparation and editing of text, selection and processing of images.

Once the manuscript is completed and accepted by the Trust, partners identified, and a funding source secured, Phase III and Phase IV of the project will be developed as follows:

<u>Phase III</u> Book design, layout, professional editing, and printing;

<u>Phase IV</u> Publication distribution and marketing.

Phase III and IV are not made a part of this contract.

Interviews will be conducted chronicling preservation efforts over the last several decades by the state's most stellar and active preservation leaders and earliest professionals in the field to include but not be limited to:

The final manuscript publication will contain the following five (5) components:

<u>PREFACE</u> - Book rationale, overview, and acknowledgments to include but not be limited to the following:

In 2014 the State of New Jersey will be commemorating the 350th anniversary of the arrival of English settlers. An anniversary presents an opportunity to re-examine history. However, one thing that you cannot easily research is the history of the historic preservation movement in New Jersey. To our detriment, the documentation on New Jersey's role within the larger context of national preservation, nor the collection of individual achievement in saving the tangible remains of our past, has never been assembled, nor presented to the public.

IV. Services and Funding

A. Deliverables

• At a pre-determined date, but within ninety days of contract start, consultant shall provide the following narrative summary for the purposes of seeking a potential publisher:

General description of the book's purpose, content, format, audience, length, and special features, including illustrations (projected number, black and white or color)--3-10 pages.

2. Table of contents or chapter outline, with short summaries of each chapter or section (about a page per chapter).

3. One or two sample chapters.

4. Market for the book: e.g., scholarly or professional organizations whose members would be most interested, potential for classroom use as required or recommended reading, competing books and how yours differs from them.
5. Timetable for completion.

- The final work product shall include 10 spiral bound copies of the manuscript delivered to the Trust and two (2) electronic digital copies in CD-ROM diskette format. Final Manuscript shall be formatted consisted with the *Author and Editor Guidelines: Manuscript Preparation and Book Production* as specified by Rutgers University Press, and can be found: http://rutgerspress.rutgers.edu/acatalog/Author_Editor_Guidelines.html
- Research File one hard copy and (2) electronic digital copies in CD-ROM diskette format
- Image file containing electronic images suitable for publication of 300 dpi or greater, with accurate accreditation as may be required; and list of potential images suitable for publication where owner permission must be obtained.

B. Work Schedule:

Fieldwork and research in New Jersey repositories will commence from the date of execution of this agreement and will last approximately four to six weeks.

At a point in time agreed to between client and consultant, consultant shall provide the necessary summary to the Historic Trust for purposes of seeking potential publisher.

A hard copy of the draft manuscript including all supporting materials, is to be submitted within ninety (90) days of completion of fieldwork.

The draft manuscript will be provided to anonymous readers selected by the Trust

who will review and comment on the draft report. The Trust will in its discretion, and in consultation with the advisors and readers, provide the comments to the Consultant.

Trust review time of the draft report will be within sixty (60) days of receipt of the draft report.

The final manuscript is to be submitted within forty-five (45) days of receipt of comments from anonymous readers.

Acceptance will be within thirty (30) days of receipt of the final manuscript research file and image file.

C. Copyright:

This agreement assumes that the consultant has been engaged as an 'author for hire'; the copyright of this project will belong to the Trust. The Trust reserves the right to use the project content or any part thereof for the purposes of the Trust's mission in the dissemination of information for educational public awareness, understanding and outreach, for the interpretation, programming, and preservation of historic sites and cultural resources, and the preservation history, in the State of New Jersey.

D. Project Cost:

The cost of the Project will be \$34,000 for the manuscript and deliverables conforming to the standards listed herein. The Consultant shall be reimbursed for professional services rendered pursuant to performance of this agreement in three installments upon Trust receipt of acceptable deliverables and invoices submitted by the Consultant per the identified schedule with detailed summary of services performed charged to the Trust.

The Trust will reimburse Consultant in an amount up to a maximum of \$2,000.00 for "out-of-pocket" expenses borne in performing the consulting services under this Agreement, which may include costs associated with entrance fees to certain research repositories, costs associated to obtain permission for use of images in future manuscript publication or in the reproduction of historical images, or other costs that may be associated with original research. Consultant shall notify client and seek pre-approval before incurring these expense.

Consultant may not be reimbursed for normal commutation, nor for over- night accommodation within state. Any expectation for travel reimbursement must be pre-approved.

E. Payment Schedule

A first installment of \$15,000 to be paid upon delivery to the Trust of the hard copy of the draft report; anonymous readers selected by the Trust will review and comment on the draft report. The Trust will in its discretion, and in consultation with the advisors and readers, provide comments to the Consultant.

A second installment of <u>\$10,000</u> to be paid upon delivery to the Trust of the final report submitted by Consultant in response to and subsequent to review comments provided to Consultant by the Trust in its discretion, and in consultation with the advisors and readers.

A third installment for the <u>balance</u> to be paid upon Trust's acceptance of the manuscript and delivery to the Trust of 10 spiral-bound copies of the final manuscript and two electronic digital copies in CD-ROM format; research file in hard copy and electronic format; and image file. Distribution of these copies will be at the discretion of the Trust.

Research and travel expenses will be reimbursed on an actual cash receipts basis up to a maximum of \$2,000.00.

V. Termination

This agreement may be terminated by either party upon 10 days written notice to the other party; where upon neither party shall have any obligation to the other except for work performed prior to the date of receipt of the notice of termination, and "out-of-pocket" expenses incurred by the Consultant prior to the date of termination.

VI. Additional Terms

A. The Consultant shall be reimbursed for such expenses upon Consultant's submission of actual receipts.

B. As part of his duties under this contract should Consultant travel by automobile, without limiting his liability under this agreement, the Consultant shall procure and maintain at his own cost and expense, during the life of this Agreement, Comprehensive Auto Liability Insurance; Bodily Injury, including death in the amounts of \$100,000 each person and \$300,000 each occurrence; and have the Trust named as an additional insured on the policy.

C. Acceptance by the Consultant of said payment shall operate as, and shall be a release to the Trust from all claims and liability to the Consultant for anything done or furnished for, or relating to, the work called for or to be done under this agreement.

D. The Consultant shall defend, indemnify and otherwise save harmless the Trust, its Trustees, officials and employees from any and all third party claims or actions at law, expenses and costs of every kind and description to the extent resulting from any acts, including errors and omissions, of the Consultant or his representatives or agents in the

conduct of the work performed under this Agreement.

E. This Agreement shall not be transferred or assigned to any other individual, firm, partnership or corporation without the prior written consent of the Trust.

F. The Agreement shall be construed according to the laws of the State of New Jersey, insofar as existence of a contract as a binding agreement and matters concerning performance or breach thereof are concerned. Any legal action will be brought in the courts within the State of New Jersey.

G. Provisions contained herein or incorporated herein by reference constitute the entire Agreement and supersede all previous communications or representations, either verbal or written, between the parties hereto with respect to the subject matter hereof.
