When submitting final plans to be released, you have the option to supplement the paper plans with a copy on compact disk (CD) or digital versatile disk (DVD). Because electronic submission of the department file copy is strongly encouraged, only the following file formats will be accepted: PDF, XML (with viewer), DWF (with viewer), DWG (with viewer), TIFF and JPEG.

When submitting final plans on a CD or DVD that includes multiple files, please name files to clearly indicate the contents of the drawing e.g. building\_structural.pdf, building\_egress.xml, plumbing\_rough.dwf, electrical\_rough.dwg, building\_interior.jpeg. Additionally, the disk should be labeled and include the following: Firm Name, Project Title, DCA Project #, Building Name, Building Address, Block/Lot, Drawn By-Initials and Date.

Applicants who submit final plans on disk must also submit a “Certification of Final Plan” form to be completed by each responsible architect or engineer. All drawings must be viewable; otherwise the applicant will be required to submit revised copies on an additional disk.
