In these LEA's, the Bureau of Housing Inspection will not cite any violations under the UFC. They will, however, cite an owner for failure to have a certificate of inspection. In all other LEA's, the Bureau of Housing Inspection will cite any violations of the UFC retro-fit provisions. **Special note for fire districts:**

In those municipalities where there are **multiple enforcing agencies all the LEA's must make the same selection** on enforcement or BHI will retain jurisdiction.
