Attached is a roster listing the Local Enforcing Agencies (LEAs) responsible for enforcing the Uniform Fire Code within the State of New Jersey as required under (N.J.A.C.5:70-1 et seq.) as of June 30, 2017.

During the year 2017, we will publish three cumulative updates to this Registry consisting solely of changes. Although local jurisdiction is not effective until publication of an Annual or Quarterly Registry, we may assume jurisdiction at any time. The next deadline for changes to the Registry is September 30, 2017. After that date, a Fourth Quarterly Update will be published in October 2017.
