**BASE BID:**

Remove and properly discard the existing heating and domestic hot water equipment along with all associated controls in a five (5) story residential Senior Citizen apartment building and replace with three (3) high efficiency gas-fired boilers and two (2) indirect storage tanks as well as new associated control panels, piping (copper), duct and electrical work.

Bids will be received in sealed envelopes marked "Morristown Housing Authority 29 Ann Street Heating" on the outside. Three (3) complete sets of bids must be provided. No bids will be accepted after the due date and time specified for any reason. They will immediately be opened and read aloud (room to be used can be obtained in reception area). After the Bid Opening on July 1<sup>st</sup>, Bid Packets may be reviewed after the opening starting July 2<sup>nd</sup> if a bidder so desires by making an appointment.

All bids shall be accompanied by a bid bond made out to the Morristown Housing Authority and Proceed, Inc. in the amount of 10% of the bid up to twenty-thousand dollars (\$20,000.00) and shall include an appropriate Consent of Surety by an appropriate Surety qualified to do business in the State of New Jersey and listed on the Federal Register "Department of Treasury" Circular 570.
