NOTICE OF REQUEST FOR BIDS
HIP 11 Grant: Hot Water System Replacement
Project Location: Back Bay Gardens, 535 Ave A, Bayonne NJ 07002

The scope of work includes, but is not limited to, the following items:

- Remove and replace two LAARS hot water delivery systems
- Remove and replace two 119 gallon water storage tanks
- Provide required controls, piping, pads and electrical wiring
- Mandatory site visit prior to submitting bid.

Sealed proposals will be received by the Bayonne Economic Opportunity Foundation (herein after called B.E.O.F.) at the Administrative Office located at 555 Kennedy Blvd., Bayonne NJ 07002 by **10:00AM Thursday August 6th 2015** prevailing time. Public opening of said bids will immediately follow.

The bid documents for the project are on file and may be examined at the administrative office of B.E.O.F. weekdays between 9am and 4pm.

No bids will be received by mail and all bids shall be submitted on the bid forms furnished by B.E.O.F.

No bids shall be withdrawn for a period of sixty (60) days subsequent to the opening of bids without consent of the B.E.O.F.

B.E.O.F. reserves the right to reject any or all bids and also reserves the right to waive any informality in the bids and to accept the bids and award the contracts to the bidder which, in its judgement, best serves in the interest of the B.E.O.F. The bids must be enclosed in a sealed envelope; properly addressed with the name of the bidder with the designation HIP 11 HOT WATER SYSTEM and addressed to B.E.O.F. HIP 11 Program, 555 Kennedy Blvd., Bayonne NJ 07002.

Bidders are required to comply with the provisions of N.J.S.A. 10:2-1 through 10:2-4 and public law 1975 127.

Bidders are required to have Pollution Occurrence Insurance which includes lead contamination coverage.

Bidders are required to have a Certificate of Liability Insurance for each occurrence, as follows: \$500,000.00 for bodily injury, \$500,000.00 for property damage, and \$100,000.00 for workers compensation. A Certificate of Insurance designating Bayonne Economic Opportunity Foundation as a certificate holder must be included with each bid proposal. Further, affidavits for both affirmative action and non-collusion, which need to be signed and notarized, must be included.

Davis-Bacon Commercial Wage Rates apply for this project.
