#### **BASE BID:**

Remove and properly discard the existing domestic hot water equipment along with all associated controls in a eleven (11) story residential Senior Citizen apartment building and replace with two (2) high efficiency gas-fired boilers and three (3) indirect storage tanks as well as new associated control panels, piping (copper), duct and electrical work.

Bids will be received in sealed envelopes marked "Housing Authority of Elizabeth 69 Division Street DOMESTIC HOT WATER BID" on the outside. Three (3) complete sets of bids must be provided. No bids will be accepted after the due date and time specified for any reason. They will immediately be opened and read aloud (room to be used can be obtained in reception area). After the Bid Opening on March 10<sup>th</sup>. 2015, Bid Packets may be reviewed after the opening starting March 12<sup>th</sup>. 2015 if a bidder so desires by making an appointment.

All bids shall be accompanied by a bid bond made out to the Housing Authority of Elizabeth and Proceed, Inc. in the amount of 10% of the bid up to twenty-thousand dollars (\$20,000.00) and shall include an appropriate Consent of Surety by an appropriate Surety qualified to do business in the State of New Jersey and listed on the Federal Register "Department of Treasury" Circular 570.
