Note that the DW Smith drawings also depict the Phase II restaurant/banquet facilities and hotel/conference center, which will not be built during Phase I, are not being financed at this time by the NJEDA, and will be subject to a separate NJDEP permitting timeline.

The closing on the purchase of 117 Channel Drive is dependent upon approval of the NJEDA financing and is included in Phase I.

The demolition of the buildings that were destroyed by Superstorm Sandy is subject to approval of the NJEDA financing. As indicated in the attached drawings, Phase I does include demolition of buildings damaged by Superstorm Sandy. We do not know the date of their construction, though presumably they were built after 1978. While we have not performed a "formal asbestos or lead paint" survey, the buildings to be demolished have been inspected many times by surveyors and engineers on our behalf in preparing our construction and permitting documents. No engineer has noted any evidence of either asbestos or lead paint in any of the structures. We will consult with our engineers this week, if it is determined that the buildings predate 1978 and if it is determined that a formal investigation for asbestos and lead paint is required by regulation prior to demolition, we will commission such an investigation this week. We are confident such an investigation, if legally required, would confirm no asbestos or lead paint in the structures planned for demolition.
