After review of the shapefile you submitted, ENSP has concluded that the project will not affect Northern Long-Eared Bat based on the lack of visible forested areas within the project site. There are also no Endangered and Threatened animal species concerns according to DEP's "HUD Review Parcel – Centroids" layer. Any additional species concerns that there may be will be addressed in accordance with the normal Division of Land Use Regulation review process (Larry Torok is CC'd here), provided a land use permit is required.

Good Afternoon Mr. Woerner:

We are performing an CEST review for the referenced project site as part of the funding process under the New Jersey Economic Development Authority's Neighborhood and Community Revitalization (NCR) program - this application is identified as NCR38958. Due to the unique nature of this project, there is no centroid data for the site that returns a simple "Yes" or "No" answer for the presence of federally and state-listed T&E species.

Attached are the database records received on April 15, 2014 and a shapefile of the project area. The database search results summary includes the following:

On-site Data

- No rare plants or communities identified on site or immediate vicinity
- No landscape species based patches on site or immediate vicinity
- Other animals tracked by ENSP on site: southeastern beach tiger beetle

Vicinity Data

- Rare plants/communities within the vicinity: saltmarsh alkali grass
- Landscape species based patches in vicinity: 17 aves, 4 mammalia, and 3 reptilia listings
- Two other animal species in the immediate vicinity of the project site: southeastern beach tiger beetle, northern diamondback terrapin

Project Description: The proposed project entails streetscape, landscape, and lighting improvements along Landis Avenue between 43rd and 39th Streets, in the central business area of Sea Isle City.
