Hello Mr. Woerner:

We are performing an Environmental Assessment for the referenced project site as part of the funding process under the New Jersey Economic Development Authority's Neighborhood and Community Revitalization (NCR) program - this application is identified as NCR39437. Due to the unique nature of this project, there is no centroid data for the site that returns a simple "Yes" or "No" answer for the presence of federally and state-listed T&E species.

This project does not require a land use permit.

Attached are the Natural Heritage Database records received on July 30, 2014 and a shapefile of the project area. Also attached is a map made using the NJDEP Tool, showing the part of the project area to be a habitat for northern long-eared bat.

Project Description:

The purpose of this project is to install streetscape improvements along New Jersey State Highway Route 166 in the Borough of South Toms River from Admiral Avenue to Herflicker Boulevard. The total project cost is estimated at \$600,047 with EDA grant funding \$600,047.
