Hello Mr. Woerner,

We are performing a CEST review for the following project as part of the New Jersey Superstorm Sandy CDBG Neighborhood and Community Revitalization (NCR) program:

NCR40023 Emergency Operations Center/Coast Guard Building complex: The Emergency Operations Center/Coast Guard Building is located on Long Beach Island and situated on a lagoon front parcel of land. The planned improvements include: new siding; windows; flood proof entry doors; re-grading of the parking lot; demolition of the existing wooden staircases and construction of new entry stairs and platform on the north and west sides of the building; and the installation of an elevator to ensure the building is ADA compliant. No DLUR permit is required for this action.

Attached is an endangered species map (see NCR40023_EndangeredSpeciesMap_NCR_TO1067) using the NJDEP Environmental Review Tool showing the project site and centroid query. As you can see in the map, we have a centroid hit for a state listed endangered species. Please provide us a determination/resolution regarding potential effects and necessary mitigation associated with the proposed project on state listed endangered species
