## Hello Lauren,

Based on what we can see on the plans and your description, we can make several assumptions.

First, based on the attached MOU that the NJMC and NJDEP signed in 2005 (item no. 2), if a project requires a zoning certificate (our term for a site plan approval), then the NJDEP determines consistency after receiving a copy of a zoning certificate for the project, or a statement of consistency. Based on the information provided, it appears that a zoning certificate will be required for the work that is proposed at 455 16<sup>th</sup> Street, since that is private property (even though the work will be done in municipal easements). So that zoning certificate would be the coastal zone consistency recommendation from the NJMC.

Second, all of the work, including the work in the municipal right-of-way, will involve the expenditure of public funds, so a resolution from the NJMC will be required. That resolution would be provided to the NJDEP for their determination of consistency (see no. 6 in the MOU). The NJMC would not be issuing a zoning certificate for the work in the right-of-way as we do not have zoning jurisdiction over public streets.

In both of these scenarios, a statement recommending consistency can be issued by the NJMC, which would take the place of the zoning certificate and resolution (only with respect to the consistency recommendation, as both are required for the town to perform the work). In order for us to prepare that statement, we would need to see the full sheets showing the proposed work (which, of course, I know that you don't have yet). Based on what we can see in the portions of the plans that were attached, the issue is not whether or not the projects are consistent with the NJMC Master Plan; rather, in order to prepare the recommendation document that the NJDEP needs from us, we need to be able to reference the real plans.

### Good Afternoon,

I am conducting an environmental review on behalf of the New Jersey Department of Environmental Protection for a CDBG Disaster Grant application under the Hurricane Sandy Disaster Recovery Program. The proposed project activities include the reconstruction and improvement of five different roads-Kero Road, Jomike Court, Barell Avenue, Eastern Way, and Starke Road—and associated drainage inlets within the Borough of Carlstadt, Bergen County, New Jersey. Additionally, storm water system improvements will be completed at 455 16th Street. The scope of this project will include the reconstruction of various outfalls, the installation of a backflow preventer / check valve, the purchase of equipment for ongoing maintenance (Caterpillar wheel loader, Caterpillar skid steer, dump truck, and a camera truck), the purchase of Tiger Dams, and the reconstruction of roadway surfaces. Activities at the Kero Road project location will involve street repaving (approximately 110,000 square feet) from the intersection of Kero Road and Washington Avenue through the end of Kero Road (cul-de-sac). Activities at the Jomike Court project location will involve street repaving (approximately 52,000 square feet) of Jomike Court, southeast of Washington Avenue (intersects with Washington Avenue at start and end points). Activities at the Barell Avenue project location will involve street repaying (approximately 92,000 square feet) from the intersection of Barell Avenue and Washington Avenue through the south end of Barell Avenue. Activities at the Eastern Way project location will involve Street repaying (approximately 32,400 square feet) from the intersection of Eastern Way and Moonachie Avenue through the south end of Eastern Way. Activities at the Starke Road project location will involve street repaving (approximately 144,000 square feet) from the intersection of Starke Road and Gotham Parkway to the Carlstadt - Moonachie municipal line as well as the reconstruction of three handicap ramps. Activities at the 455 16th Street project location will involve storm water system improvements with associated soil erosion and sediment control as well as associated excavation and concrete reconstruction. Storm water system improvements include installing a concrete headwall, four 10' concrete manholes, 575 linear feet of elliptical concrete pipe, a TideFlex valve, and five storm connections. All of these combined reconstruction activities will address the damage to the drainage system and roads caused by Superstorm Sandy and associated flooding events. The final product will result in new and improved roadways and drainage systems for the associated areas. These improvements do not involve any change in land use, will allow for the continued safe use of these roadways during future potential flooding events, and will effectively reduce damage from flooding to nearby public and private infrastructure by allowing for proper and timely storm water drainage. Additional specifics for this project are listed below.

Site location maps of each site showing site positions in the Hackensack Meadowlands, photo logs for each site, and comprehensive site maps showing positions of the entire project area and location in the Hackensack Meadowlands (including proximity to the MHWL) are attached. I am requesting your review of the site for

compliance with Coastal Zone Management. Additionally, I am requesting guidance as to if a Zoning Permit is required. Please let me know if you need any additional information to complete your review.
