- 1 Brigantine NA (Atlantic Co)
- 1 Pork Island WMA (Atlantic Co)

(saw some at Sandy Hook as well, but no formal survey conducted)

Honckenya peploides at Holgate (3 plants), Little Beach (1 plant), Brigantine (<10 plants in 2 clusters), Sandy Hook (1 plant)

Polygonum glaucum at Long Branch (1 plant), Belmar (1 plant), IBSP (1 plant), Sandy Hook (2 plants)

Oenothera humifusa at all the usual places

Sesuvium maritimum at Holgate, Little Beach Island, Avalon, Brigantine, Pork Island WMA

Several other additional new coastal species populations (Carex silicea in northern LBI, Manasquan, Artemisia campestris in Mantoloking, Eupatorium coelestinum along GSP near exit 4 Wildwood, Plantago maritima at Great Bay Blvd WMA, Little Beach Island, Stone Harbor, plus a few others that I have to look further into.)
