Yes it is outside the 9 counties and it is a single family home. We will use this language from the Tier 2 conditions if you approve:

Sole Source Aquifers

Comply with all laws, regulations, and industry standards.

Storage tanks below the base flood elevation must be watertight and must be anchored to resist floatation and lateral movement during a storm surge or other flood

The total impervious area of a parcel must not be increased significantly. In general, an increase in impervious area of more than 30% will be considered significant. The threshold of significance may be greater than 30% for parcels on which the current impervious area is unusually low, and may be less than 30% for parcels on which the current impervious area is unusually high.
