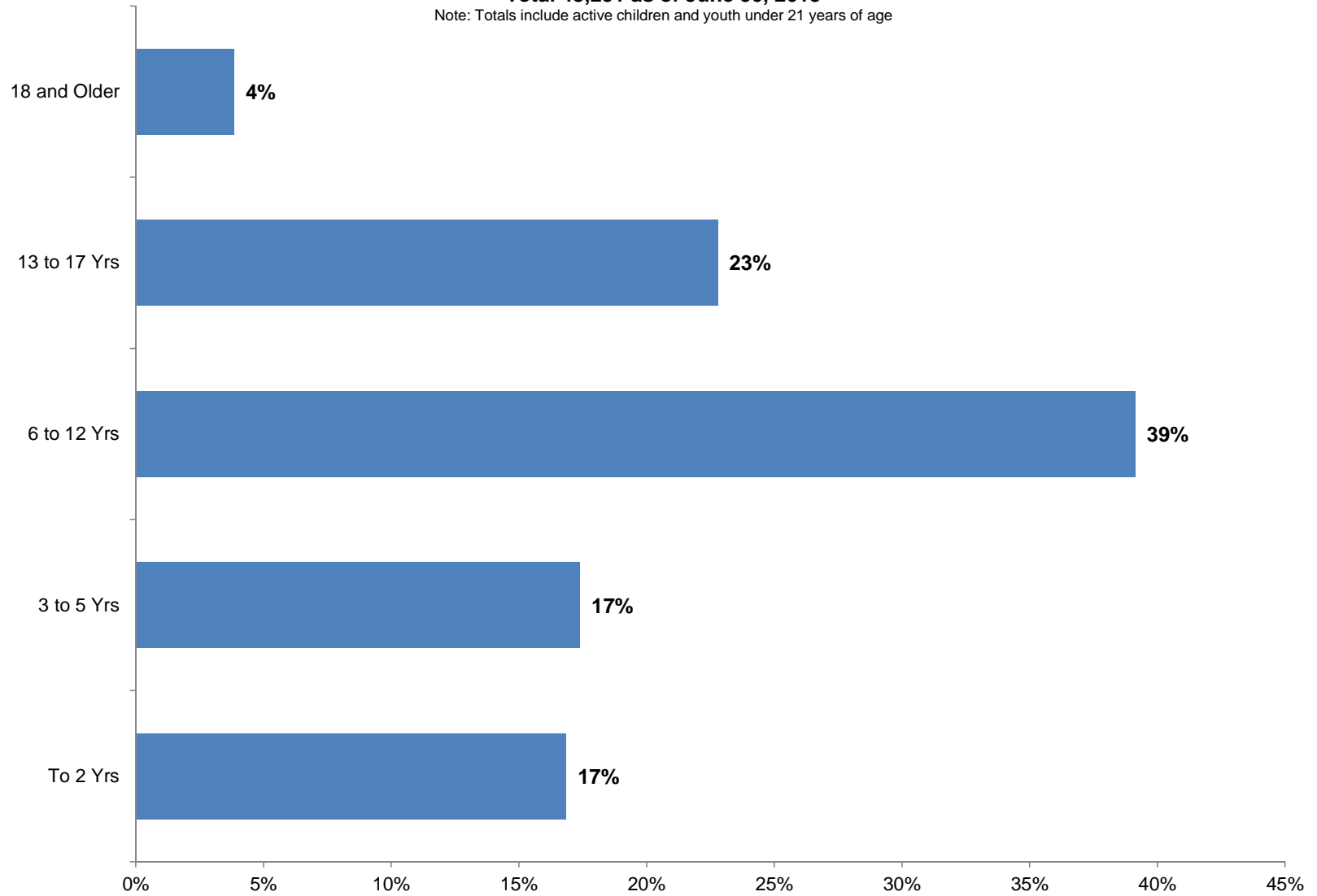

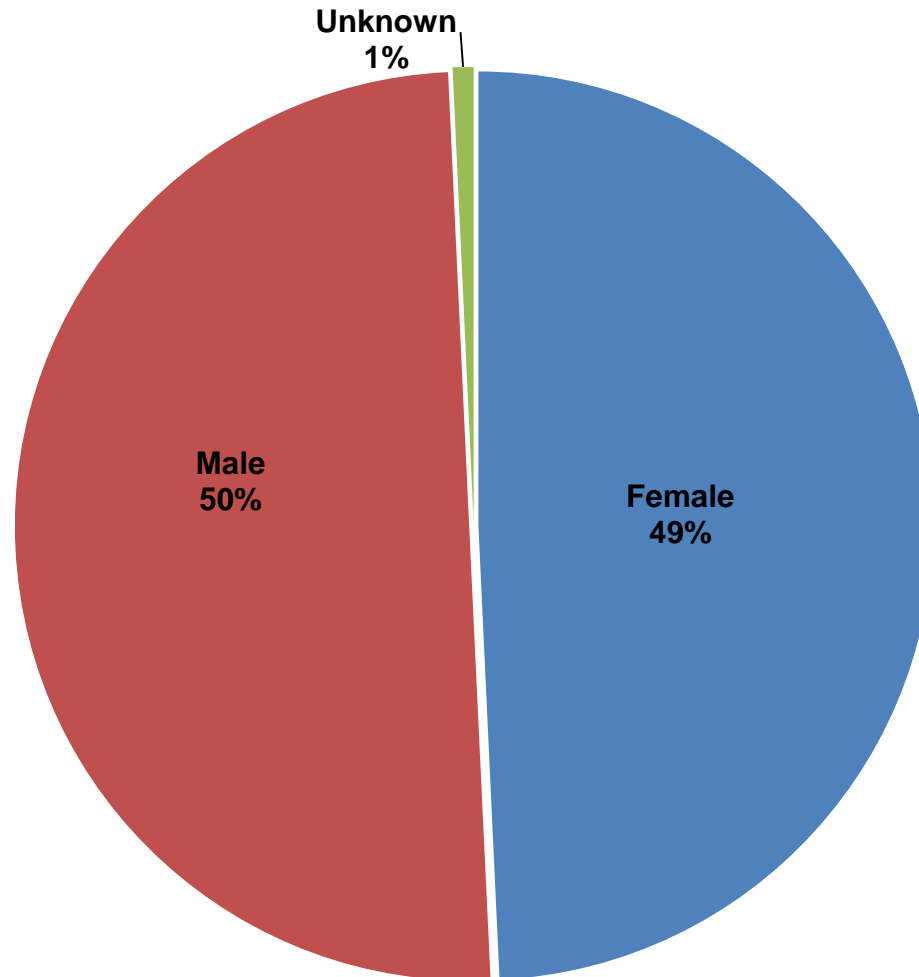




## Gender of Children In Own Home Receiving CP&P Services

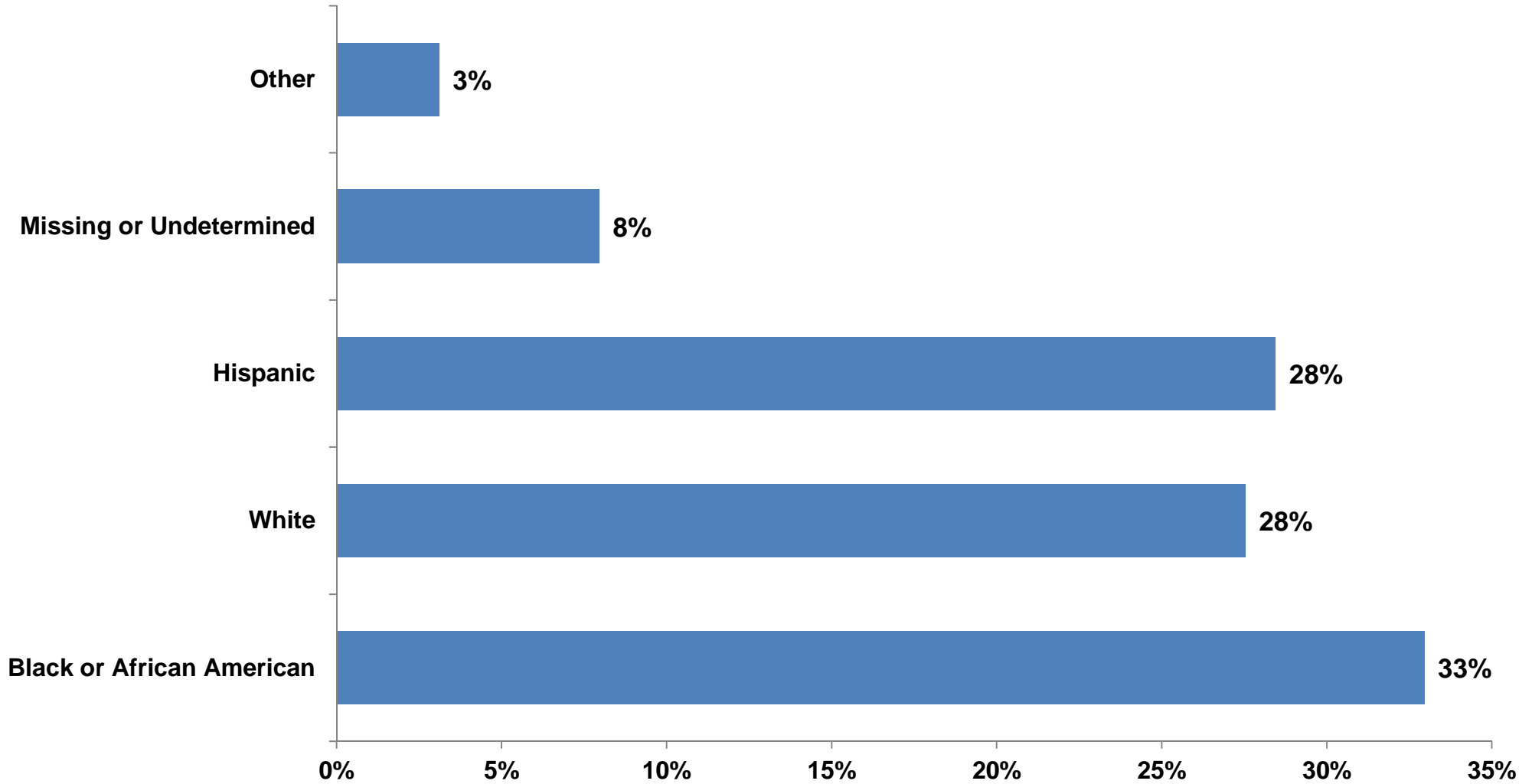

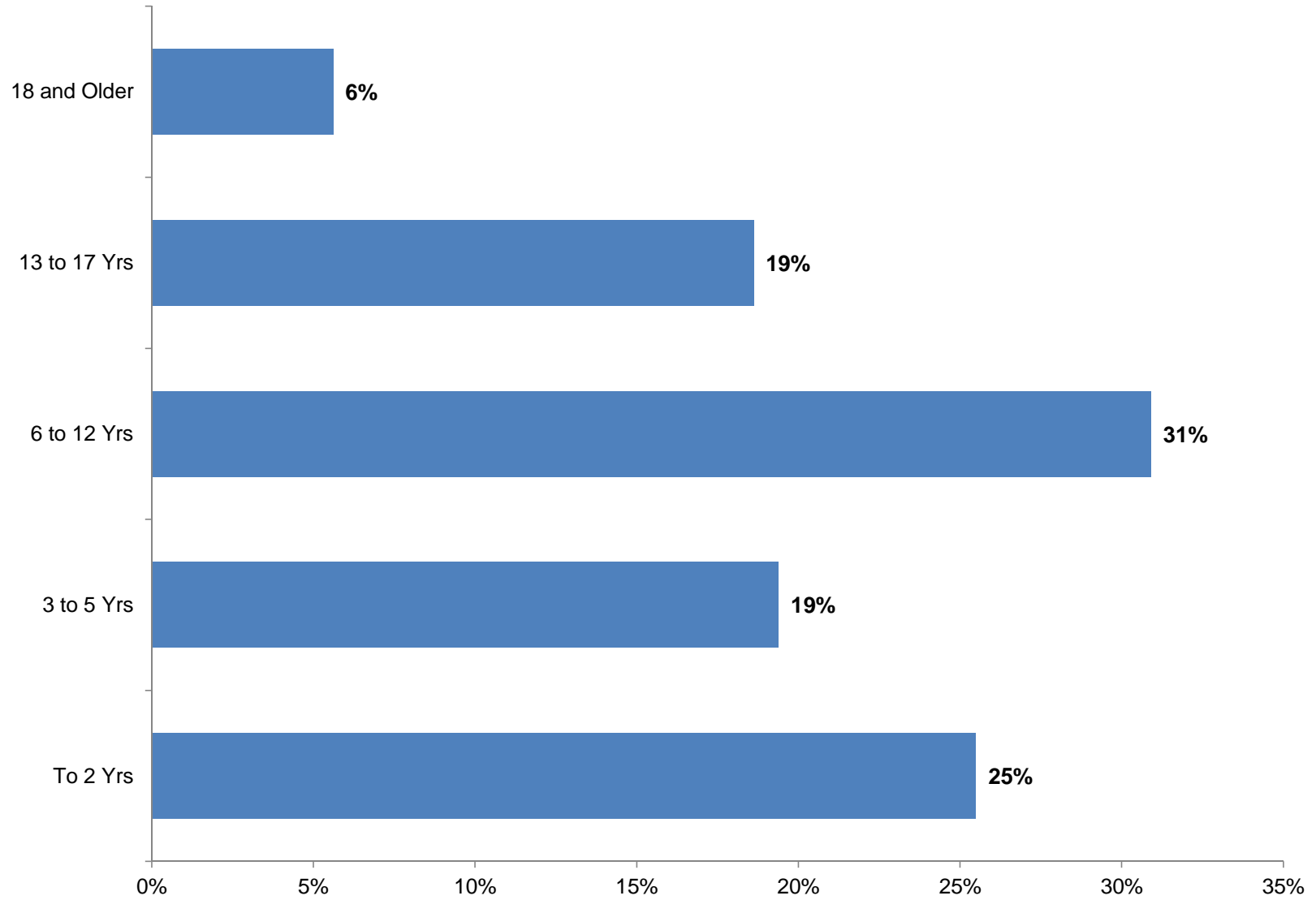

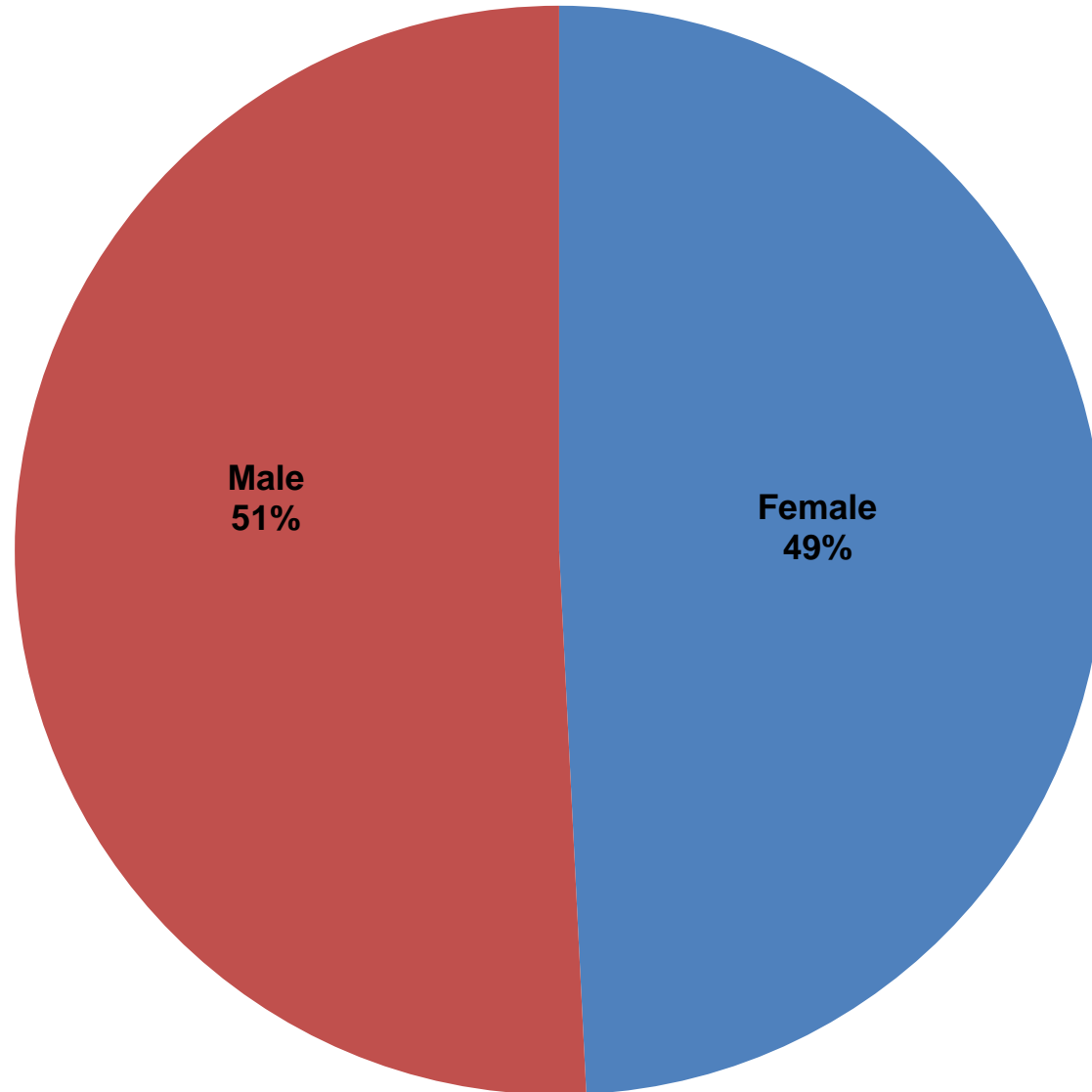




## Gender of Children in CP&P Out-of-Home Placement

**Total = 7,501 as of June 30, 2015**

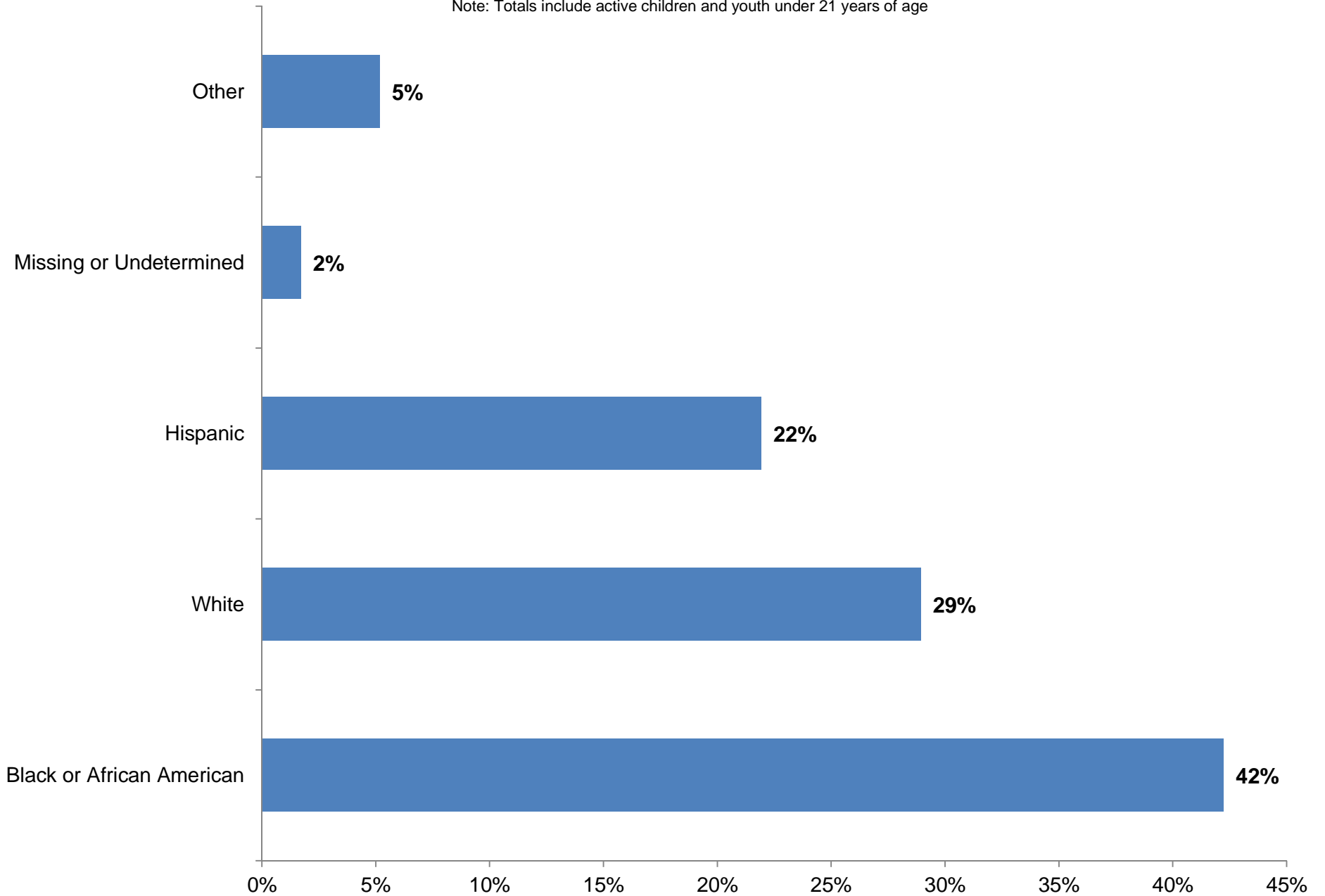

## Race / Ethnicity of Children in CP&P Out-of-Home Placement Total = 7,501 as of June 30, 2015

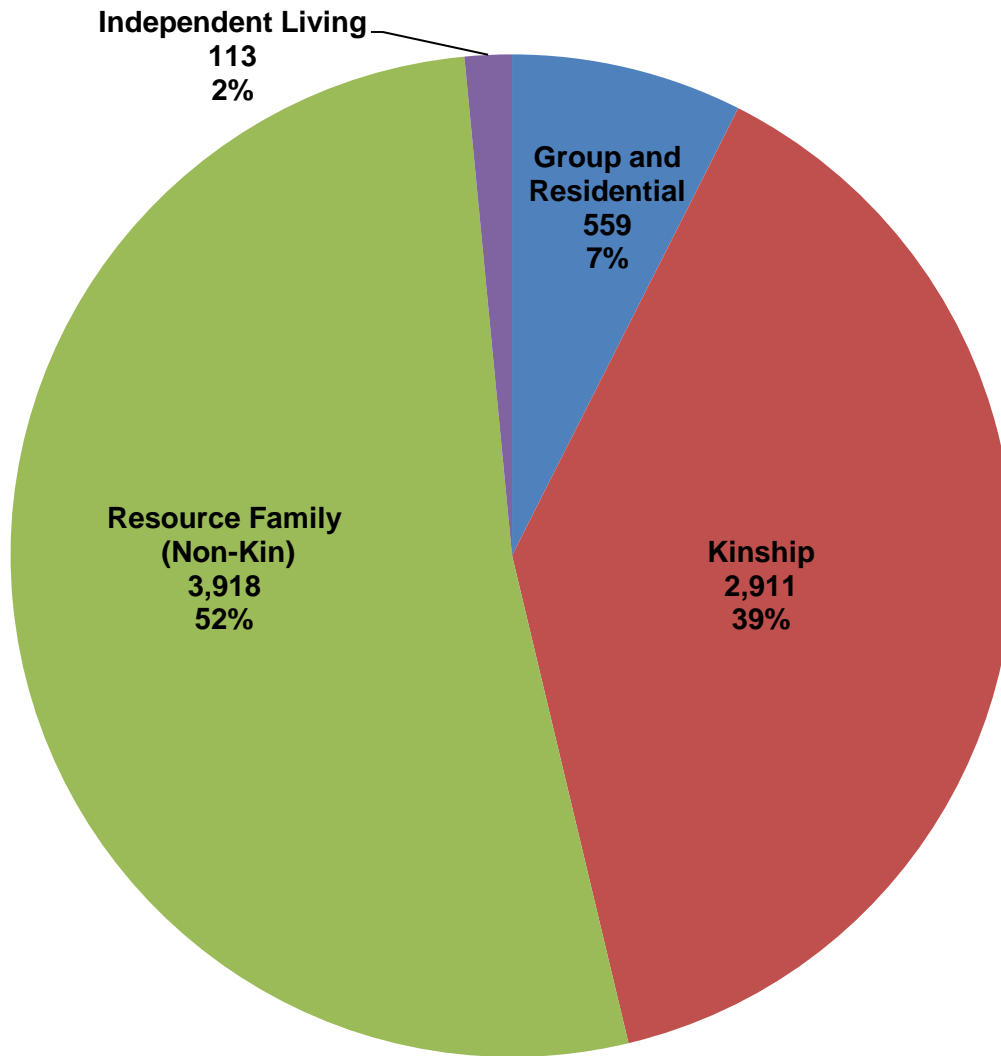
