- Recommendations and information regarding paid versus volunteer mentoring relationships.
- Monitoring the quality and impact of a mentoring relationship on youth well being.

  - b. Please list staff in order of preference to attend (not all staff may be able to attend due to space limitations).

If an interested stakeholder is not affiliated with an organization please submit a Letter of Interest to Attend with the following:

- 1. A brief overview (no more than one page) outlining your interest and /or expertise in mentoring (no more than one page).
- 2. Your full name, email address, and phone number.

After all Letters of Interest to Attend are received, the DCF Office of Adolescent Services will send notification by March 1, 2017. For those who apply timely to attend, DCF will provide the location of and all other logistics for the listening session.
