Registration Form**

Registration is required for any manufacturer of covered electronic devices (CED) offered for sale for delivery in New Jersey. A registration fee of \$5,000.00 must be submitted with this registration form to the address listed above. If a manufacturer's market share is .01 percent or less in the previous program year, no registration fee is required. Initial fee(s) for first time registrants shall be paid via check or money order payable to "Treasurer, State of New Jersey". Registration fee and form must be submitted by January 1, annually. All renewal registrations and fees must be submitted through the online portal.
