SOLID WASTE TRANSPORTER REGISTRATION

Enclosed are your 2015-2017 **solid waste transporter decal(s) and registration cab card(s).** Please read this 2-sided instruction sheet for proper placement of the decal(s). Transporter registrations forms including: Request for Additional Solid Waste Transporter Registration (Add-On); Waste Origin & Disposal (O&D); and Lease Certifications are available at our website: <u>http://www.nj.gov/dep/dshw/hwr/regislic/lru.htm.</u>

IMPORTANT NOTES:

▶ Before applying any decal, check that all information printed on the registration cab card is accurate for each vehicle. If there is an error or discrepancy, please mail a **copy** of the **registration cab card** and send it with an explanation of error to the above address.

► If you have registered more than one vehicle, be sure to affix the correct decal to the corresponding vehicle. You should view the vehicle information listed on your registration cab card prior to placement.

▶ Decals must be affixed to all solid waste units prior to transport of waste to, from or within New Jersey or prior to the unit being placed into service or before receiving waste. All decals with an expiration date of 6/30/2015 are invalid and **must be removed** upon receipt of the enclosed decals. Only vehicles with current decals and registration cab cards showing the expiration date of <u>June 30. 2017</u> will be considered valid.

NJDEP SOLID WASTE DECAL INFORMATION & VOLUME COMPUTATION FORMULA

In accordance with N.J.A.C. 7:26 3 <u>et seq</u>., the New Jersey Department of Environmental Protection is responsible for issuing solid waste registration decals. Each registrant (transporter) is being assigned a unique five-digit New Jersey Department of Environmental Protection (NJDEP) registration number. All vehicles used in the collection or transportation of solid waste must carry the current NJDEP registration (cab card) in the solid waste vehicle. Each piece of registered equipment will be issued one (1) decal. Accurate records of all waste picked up and disposed (by quantity and waste ID numbers) must be kept.

N.J.A.C. 7:26-3.4 (h)_requires that all registrants **display in letters and numbers at least three inches in height the NJDEP number, the company/trade name and the capacity of the vehicle**. This information must be **permanently displayed by the registrant on the driver's side of each registered solid waste vehicle and container in contrasting colors** so as to be visible to the operator of the solid waste facility.

EXAMPLE OF VOLUME COMPUTATION: The capacity in cubic yards can be obtained from the manufacturer or by the following method:

MEASURE THE :	EXAMPLE
Length of vehicle bed (in feet*) "L"	3 ft., 4 in. = 3.33 ft.
Width of vehicle bed (in feet*) "W"	3 ft., 6 in. = 3.50 ft.
Height of vehicle bed (in feet*) "H"	*Do not round to less than two decimal places.

The formula is: $L \times W \times H = V$ olume in cubic feet.

Then divide the cubic feet by 27: Volume in cubic feet/27 = Volume in Cubic Yards

Round off to the nearest cubic yard.

The registrant is responsible for the accuracy of the volume reported within 0.50 cubic yard regardless of the method used to obtain or calculate the volume.

HOW TO DISPLAY YOUR SOLID WASTE NJDEP NUMBER AND DECAL

Using letters and numbers at least <u>3 inches in height</u>, paint or affix the letters "<u>NJDEP</u>", your unique <u>NJDEP number</u> and the <u>carrying capacity</u> to your <u>vehicle or container</u>, then **PERMANENTLY affix the decal** below to a clean surface. This information must be displayed on the <u>DRIVER SIDE</u> of the vehicle in the area indicated by the arrows **below** so that it will be visible to the operator of the waste facility. Your <u>registered company name</u> (official company name that was registered with the State of New Jersey, Division of Commercial Recordings) **must also be** <u>displayed</u> in at least <u>3 inch letters</u>.

Your registered company name must be displayed in at least 3 inch letters on your vehicle/equipment.
