The New Jersey Department of Environmental Protection's Division of Sustainable Waste Management, Bureau of Solid Waste Planning and Licensing is in receipt of a request for administrative action to the New Jersey Sports & Exposition Authority District Solid Waste Management Plan (District Plan) dated March 23, 2023. This request for administrative action to the District Plan proposes District Plan inclusion of the acceptance and processing of a maximum of 500 tons per day (tpd) of Class A recyclable material (paper, cardboard, metal, glass, and plastic) at the Sajo Transport, Inc. Transfer Station/Material Recovery Facility (TS/MRF) located on Block 175, Lot 1 (partial) and Block 177, Lot 1 (partial), 100 Baler Boulevard, in the Borough of North Arlington. The total capacity of the Sajo Transport, Inc. TS/MRF shall remain at 2,750 tpd (up to a maximum of 12,000 tons per week) inclusive of the Class A recyclable material.

Pursuant to N.J.A.C. 7:26-6.11(b)5, County Plan inclusion of the modification of an existing facility, including the acceptance of additional waste types, constitutes an approvable administrative action. Therefore, the County Plan inclusion of the acceptance and processing of Class A recyclable materials at Sajo Transport, Inc. TS/MRF is hereby approved as an administrative action pursuant to N.J.A.C. 7:26-6.11(f).

Please be advised that this administrative action approval shall not be construed as an expression of the Department's intent to issue a permit modification to the subject facility for the above noted operational changes.
