Hazardous Waste Compliance Monitoring Fees

N.J.A.C. 7:26G-3.3(g) requires the Department to calculate the hazardous waste fee hourly rate for the state fiscal year as of the December of that State fiscal year. Pursuant to N.J.A.C. 7:26G3.3(h), the hourly rate is then multiplied by the specific task hours for each type of activity for which the Department charges a compliance monitoring fee to derive the compliance monitoring fee for that activity. **For FY 2011, the Department determined not to adjust the compliance monitoring inspection fees.**

Category	Compliance Monitoring Fee
Large Quantity Generator (Manifested \geq 12,000 kg or 26,400 lbs. of hazardous waste or \geq 1 kg or 2.2 lbs. of acute hazardous waste)	\$970.00 (annual fee)
Small Quantity Generator (Manifested \geq 1,200 kg or 2,640 lbs and $<$ 12,000 kg or 26,400 lbs. of hazardous waste)	\$835.00 (annual fee)
Conditionally Exempt Small Quantity Generator (Manifested $<$ 1,200 kg or 2,640 lbs. of hazardous waste and has an ACTIVE EPA identification number)	\$30.00 (annual fee)

Hazardous Waste Transporter Fees

N.J.A.C. 7:26G-3.3(f)1 provides that, except for new hazardous waste transporter applicants, any hazardous waste transporter that collects or delivers hazardous waste within the State shall pay an annual fee that is the greater of either the per ton fee codified at N.J.A.C. 7:26G-3.3(f)1 or the minimum fee codified at N.J.A.C. 7:26G-3.3(f)3. The transporter registration fee is calculated by multiplying the number of tons transported in the applicable 12 month period by the per ton fee. The minimum fee is calculated pursuant to the formula codified at N.J.A.C. 7:26G-3.3(f)3 and is based on program costs. Additionally, registrants that transport no waste and new hazardous waste transporters are required to pay the minimum fee plus the actual cost of each decal beyond the initial five, at a per decal cost pursuant to the contract awarded by the Department to its decal supplier (see N.J.A.C. 7:26G-3.3(f)2 and 3).

The adjusted fees for FY 2011 are based on the program costs associated with hazardous waste transporters for FY 2011 (July 1, 2010 through June 30, 2011) and the total tons transported into or out of the State of New Jersey during calendar year 2009. The adjusted fees for FY 2011

differ from the adjusted fees for FY 2010, which were based on FY 2010 costs and total tons transported in 2008. The FY 2010 fees compare with the FY2011 fees as follows:

Fiscal Year	Per ton fee	Minimum fee	Decal price
FY 2010	\$1.02	\$80.00	\$0.12 per decal
FY 2011	\$0.84	\$80.00	\$0.12 per decal

Under the rules, bills are to be sent in March of the applicable fiscal year. Each bill will state the fee for the particular transporter for FY 2011, and will reflect the revised tonnage rate multiplied by the total tons of hazardous waste that the particular transporter transported into or out of the State of New Jersey. The registrant shall pay the fee by check, payable to "Treasurer, State of New Jersey" within 30 days of issuance of the invoice. The check shall be submitted to:
