Applications Being Accepted for the 2011 Governor's Environmental Excellence Awards

What are the Environmental Excellence Awards?

The Department of Environmental Protection (Department) is pleased to announce the application process for the 2011 Governor's Environmental Excellence Awards (GEEA). This program was established by the Department to recognize outstanding environmental performance, programs and projects in the state by businesses, municipalities, institutions, individuals and others. Each year one award is given in the following nine categories:

Clean Air Innovative Technology Environmental Education/Student Led Project

Water Resources Land Conservation Sustainable and Healthy Communities

Healthy Ecosystems Environmental Stewardship Environmental Leadership

The Clean Water New Jersey Program category awards are also included in this awards program. The Clean Water New Jersey Program promotes statewide stormwater education to reduce the amount of pollution entering the state's surface and ground waters. These awards recognize those municipalities, public complexes, and highway agencies permitted under the Municipal Stormwater Regulation Program that either go above and beyond the basic permit requirements; and/or have developed innovative approaches that have resulted in more efficient processes, significant cost savings, or mechanisms that promote cost-sharing or shared services while providing enhanced protection for water quality. One award will be given in each of the following four categories:

Tier A Municipal Stormwater General Permit
Tier B Municipal Stormwater General Permit
Highway Agency Stormwater General Permit

Who is Eligible?

GEEA nominations will be accepted from individuals, organizations, municipalities or businesses. You may nominate yourself or your company/organization as well as another company, individual or organization you believe is worthy of recognition. Self nominations in the Environmental Stewardship and Environmental Leadership categories will not be accepted.

Applicants/ projects must:

- 1) Be located in New Jersey, and;
- 2) Be active within the past year, and;
- 3) Agree to have their project shared with others through a written description to appear in an awards program and on the GEEA Web site (www.nj.gov/dep/eeawards/).

Applications may not be submitted by employees of the NJDEP. Moreover, the NJDEP, other State agencies and their employees are not eligible for awards.

Nominations for the Clean Water New Jersey Program Award category will be accepted from those entities currently authorized to discharge stormwater under the Tier A Municipal Stormwater General Permit, Tier B Municipal Stormwater General Permit, Public Complex Stormwater General Permit or Highway Agency Stormwater General Permit.

COMPLIANCE ADVISORY

Applicants/projects must:

- 1) Be able to certify that they have not had any past enforcement actions, and:
- 2) Agree to have their program information shared with others through written material distributed by the Department, and;
- 3) Be submitted only by those entities currently authorized to discharge stormwater under the Tier A Municipal Stormwater General Permit, Tier B Municipal Stormwater General Permit, Public Complex Stormwater General Permit or Highway Agency Stormwater General Permit.
