# **Organic Land Care Certification Program**

# Who is affected by this initiative?

Rutgers Cooperative Extension in association with the NJDEP Pesticide Control Program certifies professional landscapers and others in organic land care. The program is designed for professional landscapers, property managers, public works employees, groundskeepers, landscape architects and Master Gardeners. This program is not intended for recreation and sports turf field managers.

# Why should I take this course?

The federal government through the <u>National Organic Program</u> (NOP) developed national organic standards for *agriculture* and a certification program identified by the "USDA Organic" symbol, which certifies that agricultural products meet federal organic standards.

However, there are **no** federal standards for organic land care. In order to educate and assist land care practitioners in determining what is acceptable under an organic program, Rutgers Cooperative Extension in association with the NJDEP Pesticide Control Program has developed an <u>Organic Land</u> <u>Care Certification Program</u>. The program focuses on providing education on organic practices for promoting healthy soil, enhancing biodiversity, and reducing polluted runoff from managed landscapes.

# How Do I Attain Organic Land Care Certification?

To attain certification you must attend a 5-day training program and pass a certification exam. Training programs are offered on an annual basis usually in January. The registration fee for the program is \$475.00

Program certification is valid for a period of 3 years. Certification is maintained by obtaining 4 approved continuing education units (CEUs) every 3 years. Credit opportunities will be available through pre-approved classes and programs with a focus on organic land care such as full-day and half-day Rutgers Cooperative Extension (RCE) classes, Rutgers Office of Continuing Professional Education classes, and any class that offers Northeast Organic Farming Association Accredited Organic Land Care Professional (AOLCP) credits. In addition, those certified can choose to attend one day of the annual 4-day RCE organic land care certification course to earn the 4 CEUs.
