## TROUT STOCKING IN TROUT PRODUCTION, HOLDOVER AND TROPHY TROUT LAKES AND MUSCONETCONG RIVER DRAINAGE

The following hatcheries have provided documentation that their fish have been inspected for all of the below listed pathogens of concern. Permits to stock trout in waters with reproducing trout populations, designated Holdover and Trophy Trout Lakes and the Musconetcong River drainage must be obtained from a source certified free of whirling disease, Infectious Pancreatic Necrosis, Infectious Hematopoietic Septicemia, Viral Hemorrhagic Septicemia, Bacterial Kidney Disease, Bacterial Furunculosis and Bacterial Redmouth.

A stocking permit issued by the New Jersey Fish and Wildlife is required for all waters of the state. Please note that stocking permits will not be issued in the Pequest watershed. Private trout stocking is not permitted in the Pequest watershed in order to protect the biosecurity of the state run Pequest Trout Hatchery.

Permit applications may be obtained from the Bureau of Freshwater Fisheries Laboratory, PO Box 394, Lebanon, NJ (908-236-2118). This office also offers advice and recommendations relative to fish stocking and lake management.

Stocking permits will be approved only for fish obtained from hatcheries which appear on the Commercial Fish Hatchery List. The listing is reviewed annually.
