**Scope of Eligibility:** Open to applicants who meet the requirements below.

**Description:** Under supervision of an Assistant Division Forest Fire Warden or other supervisor in the Department of Environmental Protection, in a fire tower, is responsible for detecting, locating, and reporting forest fires to protect life and property from wildfire; when required, performs forest fire suppression, pre-suppression, and prevention; performs maintenance work; does related work as required.

**Specific to the Position:** Forest Fire Observers are expected to: Detect and report wildfires, dispatch initial attack fire resources, monitor fire behavior, act as a safety look-out for fire resources, observe and record weather conditions, and help maintain the fire tower and tower grounds. During periods of low fire danger assist with other duties such as office coverage, construction and maintenance of fire equipment, public outreach and prescribed burning.

## Requirements

**License:** Appointees must possess a driver's license valid in New Jersey. Appointees will be required to possess a valid Commercial Driver's License (CDL) and applicable endorsements for the class and type of vehicle being operated.

**Other:** Appointees must establish residence in an assigned area within thirty (30) days of appointment. (The appointee must live within the forest region assigned.)

Appointees will be required to obtain a certification as an Instructor-Trainer issued by the New Jersey Forest Fire Service.

Appointees will be required to successfully complete forest fire training courses and maintain qualifications as a forest firefighter. Failure to maintain qualifications will result in progressive disciplinary action.

**Residency:** All persons newly hired on or after September 1, 2011 have one year from the date of employment to establish, and then maintain principal residence in the State of New Jersey subject to the provisions of N.J.S.A. 52:14-7 (L.2011, Chapter 70), also known as the "New Jersey First Act".

**Authorization to Work:** Selected candidates must be authorized to work in the United States per the Department of Homeland Security, United States Citizenship and Immigration Services regulations. **Note:** The State of New Jersey does not provide sponsorship for citizenship to the United States.

**Veteran's Preference:** To qualify for New Jersey Veteran's Preference/status, you must establish Veteran's Preference through the Department of Military and Veterans' Affairs.
