No alcohol.

No food vendors.

No balloons.

No wedding receptions/ceremonies.

No vehicular access to picnics sites, at any time. Permittee must use designated unloading zones.

No DJs or live musical performances. Radios must be kept to a minimum. Do not disturb other Park patrons.

 $\underline{\text{No}}$ generators. No access is available to electrical outlets.

 $\underline{\text{No}}$ additional grills may be brought into the group picnic areas.

No propane is permitted in the Park.

 $\underline{\text{No}}$ additional tables are permitted in the group picnic areas.

No nails, staples, glue or tape may be used to hang signage.

 $\underline{\text{No}}$ inflatables are permitted, including but not limited to bouncy houses.

Group Picnic Areas shall not be combined.


Ticketed events, concerts, organized sporting events, fundraisers, walkathons, car shows and similar events require a special use permit. Please contact the Park office for further detail.

All signage, decorations and banners must be hung at a safe height and must be removed after the event.

All trash, litter and hot coal must be placed in designated receptacles. Trash bags are available upon request at the Park Office.

All other State Park Rules and Regulations apply. Violations may result in penalties including but not limited to fines and eviction.
