Specific Potential Contaminant Source Inventory

As part of determining a public drinking water source's susceptibility to contamination, DEP identified GIS coverages of "potential contaminant sources" within each source water assessment area. New Jersey Source Water Assessment Program Plan, approved by EPA in 1999, identifies sites/activities of concern and DEP accumulated appropriate GIS data sets.

For more information on the Potential Contaminant Source Inventory please refer to Appendix B-Attachment 4, Source Water Assessment Program Potential Contaminant Source Methodology. USGS and DEP explored water quality data in relation to these coverages, and found a subset of them were statistically related to a well or surface water intake's susceptibility.

Information from all point source GIS coverages that were considered by USGS during model development is presented in this attachment.

Note that this includes coverages that ultimately were determined not to be a direct factor in determining susceptibility. The factors that were used in the final model development are known as "explanatory variables." These explanatory variables are provided in Tables 2, 3, and 4 in the report.

This attachment is organized as follows:

Potential contaminant point sources are grouped by Entry Point to the Distribution System (EPTDS). The EPTDS is identified at the top of each list by it's ID (EPTDS ID) and name (EPTDS Name). It is also noted whether the EPTDS contains ground water sources or surface water sources. Following the EPTDS heading, the individual wells and/or intakes are listed along with the well or intake identification number (SFID) and name (Source Name).

For wells, information is further broken down into tiers, 1, 2, and 3. Under each of these tiers, all of the potential contaminant point sources are provided. (If a tier is not listed, the tier did not contain a potential contaminant point source at the time the report was generated). The DEP program that regulates the potential contaminant source is listed followed by the contaminant source type. The DEP program identification number, site name, site address, site municipality, and site county, when available are also provided for each potential contaminant source.

For additional information not contained in this attachment, please refer to the Individual Explanatory Variable Inventory, Appendix A-Attachment 1, containing summaries on the complete land use and potential contaminant sources for each well and/or surface water intake.
