# MINUTES OF THE MEETING OF THE NEW JERSEY SMALL EMPLOYER HEALTH BENEFITS PROGRAM BOARD AT THE OFFICES OF THE NEW JERSEY DEPARTMENT OF INSURANCE TRENTON, NEW JERSEY July 30, 1996

### I. Call to Order

The Executive Director called the meeting to order at approximately 10:05 a.m. and announced that notice of the meeting had been published in three newspapers and posted at the Department of Insurance and the Office of the Secretary of State in accordance with the Open Public Meetings Act. # II. Report of the Legal Committee

The Executive Director reported that the Legal Committee had met to consider whether the SEH Board should continue to interpret the SEH Act to prohibit carriers from offering non-standard health benefits plans directly to new small employer groups, but to allow carriers to offer such coverage through an association, out-of-State trust, or multiple employer arrangement.

\* L. Ilkowitz made a motion to move into executive session for the purpose of receiving legal advice. B. Markowitz seconded the motion, and the motion was approved unanimously by voice vote.

The Executive Director reported that the SEH Board would proceed with proposing amendments to its regulations previously approved by the SEH Board at its June 19, 1996 meeting. He noted that the SEH Board would continue to interpret the SEH Act to prohibit carriers from offering non-standard health benefits plans directly to new small employer groups, but to allow carriers to offer such coverage on a guaranteed issue basis to members of an association, out-of-State trust, or multiple employer arrangement to which the plan was issued.

The SEH Board agreed to revised language in the draft Buyer's Guide regarding the availability of non-standard health benefits plans.
