WHEREAS Respondent Catherine Moeller, a licensed Real Estate Broker licensed by the State of New Jersey, is subject to the provisions of the Real Estate Brokers and Salesperson's Act, N.J.S.A. 45:15-1 et seq.; and

WHEREAS at all times relevant hereto, Respondent Catherine Moeller was and continues to be licensed as broker of record of Sea Breeze Realty Group, LLC d/b/a Sea Breeze Realty whose main office is located at 2017 Long Beach Blvd, Surf City, NJ; and

WHEREAS the Real Estate Commission has secured evidence which indicates that Respondent Moeller has violated certain provisions of the laws and regulations governing the conduct of New Jersey real estate brokers and salespersons as referenced above; and

WHEREAS the Commission and Respondent Moeller have agreed to settle this matter in lieu of any further administrative action; and

WHEREAS Moeller admits that she acted in violation of N.J.A.C. 11:5-5.1(b) by failing to report a change in the escrow account of Sea Breeze Realty to the Real Estate Commission and failing to have the new account labeled as an "escrow account" or "trust account," as required by N.J.S.A. 45:15-12.5a; and

WHEREAS Respondent Moeller acknowledges that she has been made aware of her right to a full and formal hearing on any violations which the Commission may allege she has committed and her right to have the advice of counsel on the matters to which this Consent Order pertains, she is knowingly and voluntarily waiving the right to a hearing and counsel; and

IT IS THEREFORE AGREED TO BY THE PARTIES AND SO ORDERED that

Respondent Moeller agrees to pay a fine in the amount of \$1,500.00; and it is further ordered and agreed that

Respondent Moeller shall pay the fine within 30 days of the date of acceptance of this Consent Order. The fine shall be payable by certified check, cashier's check or money order payable to the "State of New Jersey" and sent to:

And it appearing that this matter can be resolved upon the consent of the parties, without resort to any other further administrative proceeding;
