WHEREAS Respondent Paul F. Chiolo, a licensed real estate broker licensed by the State of New Jersey, is subject to the provisions of the Real Estate Brokers and Salesperson's Act, N.J.S.A. 45:15-1 et seq.; and

WHEREAS at all times relevant hereto, Respondent Chiolo was and continues to be licensed as broker of record of Cape Atlantic Real Estate Investments, LLC d/b/a Keller Williams Realty Jersey Shore whose main office is located at 5406 New Jersey Avenue, Wildwood Crest, NJ 08260; and

WHEREAS the Real Estate Commission has secured evidence which indicates that Respondent Chiolo has violated certain provisions of the laws and regulations governing the conduct of New Jersey real estate brokers and salespersons as referenced above; and

WHEREAS the Commission and Respondent Chiolo have agreed to settle this matter in lieu of any further administrative action; and

WHEREAS Chiolo admits that he acted in violation of N.J.A.C. 11:5-4.2 by failing to supervise a salesperson under his employ, specifically in that a salesperson within his firm had used a cargo van that was lettered with a banner which read, "Buy or Sell your home with me use this truck for FREE" and listed an unidentified telephone number which was not associated with the brokerage; and

WHEREAS Respondent Chiolo acknowledges that he has been made aware of his right to a full and formal hearing on any violations which the Commission may allege he has committed and his right to have the advice of counsel on the matters to which this Consent Order pertains, he is knowingly and voluntarily waiving the right to a hearing and counsel; and

IT IS THEREFORE AGREED TO BY THE PARTIES AND SO ORDERED that

Respondent Chiolo agrees to pay a fine in the amount of \$1,500.00; and it is further ordered and agreed that

Respondent Chiolo shall pay the fine within 30 days of the date of acceptance of this Consent Order. The fine shall be payable by certified check, cashier's check or money order payable to the "State of New Jersey" and sent to:




