Registration and Inspection Fee

Dear Applicant:

Pursuant to the Real Estate Sales Full Disclosure Act (N.J.S.A. 45:15-16.27 et seq. and N.J.A.C. 11:5-9.1 et seq.), a Notice of Filing cannot be issued and review of your filing cannot commence until all fees, including inspection fees, are paid.

In order to expedite the process, please forward two (2) checks, both made payable to the State Treasurer of New Jersey. The first check will represent the registration fee at a rate of \$500 application fee plus \$35 for each lot, parcel, unit or interest being registered. Said fee shall not exceed \$3,000.

The second check will represent estimated inspection costs. Please see the attached form for estimated costs to the area in which the subdivision is located. Kindly complete this form and submit it to this office along with the inspection fee. All inspection costs are held in a separate escrow account until the inspection is completed. Inspection costs will be accounted for and any remaining monies will be refunded.
