IT FURTHER APPEARING that, pursuant to N.J.S.A. 17:23-20 et seq., the Commissioner has authority to address inquiries to property/casualty insurers authorized to transact business in New Jersey concerning their condition or affairs on any matters connected with their transactions; and

IT FURTHER APPEARING that the Department has determined that it is necessary to review the acceptance criteria of insurers transacting private passenger automobile insurance in this State to determine compliance with the requirements governing acceptance criteria set forth in N.J.A.C. 11:3-8;

THEREFORE, IT IS on this 1st day of October, 2009
ORDERED that:

1. All authorized and admitted property/casualty insurers that have private passenger

automobile insurance policies in force on October 1, 2009, shall provide to the Department

copies of their private passenger automobile insurance acceptance criteria, as defined in N.J.A.C.

11:3-8.2, that are in effect for new and renewal business as of the date of this Order by

November 1, 2009.

2. Copies of any revised private passenger automobile insurance acceptance criteria

that are implemented prior to February 28, 2010 shall be submitted to the Department within 10

days of implementation.

3. The information supplied in accordance with this Order will remain confidential

to the extent allowed by applicable State law, including, but not limited to, N.J.S.A. 17:23-24.

4. Information filed pursuant to this Order shall be sent via e-mail to

5. Failure to comply with the terms of this Order may result in the imposition of

penalties, including, but not limited to, penalties pursuant to N.J.S.A. 17:33-2.
